A CALL TO WITVA ARTISTS FROM PALM BEACH CULTURAL COUNCIL

The Cultural Council for Palm Beach County and Women in the Visual Arts announce a call to active members of Women in the Visual Arts residing in Palm Beach County to submit two images to be considered for an exhibition at the Cultural Council in Lake Worth Beach from September 30th through November 12th 2022.

The work should be either pattern or process oriented.

For more understanding of pattern or process, please read the following:

*Pattern refers to the visual arrangement of elements in some kind of sequence or repetition such as a line of trees, a floral dress, the design of a flower, or the back-and-forth sway of the ocean.

*Process refers to where the process of making art is not hidden but remains a prominent aspect of the completed work, so that a part or even the whole of its subject is the making of the work.

Each artist may submit two total images. Judging will FIRST be conducted by our critique panel of artists from Women in the Visual Arts with FINAL approval by the Director of Artist Services at the Cultural Council for Palm Beach County. Judging will be based upon the overall quality, creativity, and vision of each work.

Criteria for the Call are as follows:

- To be eligible to apply, artists must be active members of Women in the Visual Arts and must live and work in Palm Beach County.

- Work must have been created within the past two years, with the theme of pattern or process.
- The Cultural Council for Palm Beach County is looking to feature artists that have not exhibited at the Cultural Council in the past year.
- All images must include artist name, title, date, medium, and size of work and price
- Images submitted must be at least 2400 pixels but no more than 3000 pixels on the longest side.

Deadline for Entries

Images must be submitted by July 12th. As this exhibit will only show a maximum of 15 works, we will need to limit the number of entries to two entries per artist for consideration by the jurors and for possible inclusion in the exhibit.

Accepted Work:

Artists will be notified from the Cultural Council with accompanied paperwork by **August 15th**. Please do not make phone calls to the Cultural Council. After work has been accepted, a substitution cannot be made nor a change in the artwork.

Dates To Remember:

Take In: Prepared artwork must be delivered to the Cultural Council for Palm Beach County for installation on September 27th 2022 between 12:00 and 5:00.

Show Dates: Chosen pieces will be on display at the Cultural Council for Palm Beach County from September 30 through November 12, 2022.
