- 1 -The meeting was held by Zoom call and called to order by Sheila Pinette. Introductions were not really made, but a quorum was met.
- 2 Jill Palmore/Tim Trachomowicz discussed the two quotes from Bauman Electric (with Tammaro Landscaping) and ITS Green. The difficulty of getting bids and the expense of trenching under the roadway were discussed and the poor condition of the existing lights. Safety/upgrading of neighborhood entrance was discussed. Ultimately, it was voted to go with the Bauman bid and try to lock in the price of approximately \$10,000 in the near future.
- 3 Budget: We reviewed the documents that Lisa Stevens prepared and the proposed budget for 2021. A motion was made to increase the annual fees by \$25/year (except for the house on Mitchell Road), from \$175 to \$200. Discussion ensued about increasing the reserves for potential expenses (such as damaged trees). A vote approved the change, but a homeowner can contact a board member if the increase presents a financial hardship.
- 4- Holiday decorations will be done again this year by Maria Hughes and Daryl Negele.
- 5 Given the current Covid situation, holiday parties and community gatherings are on hold.
- 6 New homeowners were welcomed and invasive species removal/management, and mailbox/post colors were discussed.
