- The Veteran's Committee Representative processed 11 CE referrals during Q4. Two referrals were enrolled in Veteran housing programs, two referrals did not meet the definition of a Veteran, and eight referrals are still pending.
- Did you know that SSVF at UVM can rapidly enroll most Veterans on the same day as screening? SSVF at UVM strives to begin connecting Veterans to community and Veteran resources from the first contact all the way through their SSVF at UVM enrollment.
