## **Program Updates from SSVF at UVM:**

- SSVF at UVM had begun Collaborative Case Management with the WRJ HUD-VASH program. SSVF has 20 available vouchers to be used in this collaborative model assisting Veterans eligible for HUD-VASH with low clinical need to find and become stable in housing.

- SSVF at UVM has 4 staff members who are SOAR certified and able to help Veterans apply of SSI/SSDI.
- SSVF at UVM works with South Royalton Legal Clinic to help Veterans enrolled in SSVF at UVM address their legal needs, including eviction, child support issues, assistance with SSI/SSDI claims, landlord/tenant issues, outstanding warrants, assistance obtaining VA benefits, driver's license reinstatement, criminal record exungement, debt collection, and discharge upgrade.
