Program Updates from SSVF at UVM:

- SSVF at UVM has begun implementing Shallow Subsidy Services! As of the end of Q2, SSVF at UVM had two clients enrolled in the new Shallow Subsidy service. SSVF at UVM is looking forward to using this new service to help house more Veterans with a concrete path to housing stability.
- SSVF at UVM has hired for both a Northern and Southern Vermont Outreach and Enrollment Service Coordinator. This is exciting news as this will enable SSVF at UVM to get back to accepting a full referral load. We are excited to welcome Katie Gagliardo in Northern Vermont and Kate Rochon in Southern Vermont. They will be in the community providing outreach and education as well as completing enrollment meetings with our newly enrolled Veteran clients.
- SSVF at UVM is still hiring for a Program Assistant based at our UVM office on Water Tower Circle in Colchester, as well as a Southern Vermont Health Care Navigator to be remotely based in the Southern part of Vermont. Successes Q2:

- All average timelines were met and exceeded for the enrollment process. This results in the Veteran being handed off to Pathways for case management services in less than a week from their screening/rapid enrollment.
- Health Care Navigation Services were provided for 14 Veterans in Q2. 1 Veteran was connected to VA Healthcare and 3 Veterans established a Primary Care Physician.

Areas of Opportunity Q2:

- Outreach goals for Q2 were largely unmet. This is due to the lack of staff in the Outreach and Enrollment Service Coordinator position. Now that these positions are staffed, SSVF at UVM is also re-evaluating outreach goals and strategies to better fit with the current community dynamic and inclusion of Coordinated Entry.
