### Program Updates from SSVF at UVM:

- Welcome to our new Southern Vermont Heathcare Navigator, Kristin Crowley!
- SSVF at UVM has availability for eligible Veterans who enroll in SSVF to be referred to our SSVF Shallow Subsidy Service. SSVF at UVM Shallow Subsidy can support 50% of rental payments for up to two years to help Veterans become stable in permanent housing.
- SSVF has transitioned 41 Veterans from traditional SSVF RRH or Prevention TFA rental assistance to Shallow Subsidy TFA since the implementation of this service. Currently there are 34 Veterans enrolled in Shallow Subsidy Services.
- SSVF has housed 32 Veterans in FY24 since October 2023. Of the 32 housed, 16 Veterans were housed within 90 days of enrollment. The overall average time from enrollment to housing through Q3 FY24 is 163 days!
