- Wills in Plain English Limited provides a quality service to clients including advice relating to Wills, Trusts and Powers of Attorney; taking instructions relating to the production of Wills and associated documents plus Lasting Powers of Attorney; advice relating to the administration of Estates and Trusts and taking instructions for creation of Trusts; advice on Inheritance Tax (IHT) planning
- In most circumstances this will involve at least one face-to-face meeting with clients, either in person at a location and time convenient to them, or online via video conferencing platform such as Microsoft Teams, in order to record information, give advice and guidance, and to take instructions.
 A further meeting or visit is usually necessary to complete any signing formalities.
 Subsequent visits may be required dependent upon the circumstances. It may sometimes be possible to deal with certain matters by telephone, post or email.
- The cost involved is governed by the complexity of advice and documentation, and time involved.
- Fees will be agreed with clients before commencement and will be invoiced for immediate payment on completion (fees are due on completion of advice where no documents are produced).
- Prices include free storage, of documents produced, for 12 months (if required by clients).
- The prices quoted cover most situations but are not exhaustive. Customers can obtain further details and quotes on application.
- Standard STEP clauses are included automatically in all Wills.
- If a visit is required out of normal office hours, at very short notice, or at considerable distance an additional charge may be made.
- Office of the Public Guardian (OPG) registration fee is £82 per LPA / £164 for both versions (single) / £328 for both versions (couple).
- A standard will covers a number of typical situations where there is no requirement for complicated or unusual provisions, including:
 - a couple who wish to leave their estates to each other and, failing that, to their children (if necessary, on reaching a specified age)
 - a couple who wish to leave their estates to each other and, failing that, to one or more named beneficiaries
 - an individual who wishes to leave his or her estate to named beneficiaries In each of these situations, the service can include provisions leaving cash legacies, disposing of personal effects, expressing any funeral wishes and, if relevant, appointing guardians.
