Human Trafficking

Two types of Human Trafficking: Labor Trafficking and Sex Trafficking



Labor Trafficking: Using force, fraud or coercion to recruit, harbor, transport, obtain or employ a person for labor or services



Sex Trafficking: Commercial sex act induced by force, fraud or coercion, or in which person performing the act is under age 18

What is Force, Fraud and Coercion?



Force

Fraud

- False Promises
- Deceptive offers
 - Employment/Wages
 - Working conditions
 - Love/Marriage
 - Better life
- Withholding wages



Coercion

- Threats of serious harm
- Debt bondage
- Psychological manipulation
- Document confiscation
- Blackmail/Sextortion
- Quotas
- Control of children

Distinction Between Human Smuggling & Trafficking

Smuggling	Trafficking
Crime against a border	Crime against a person
Transportation based	Exploitation based
Requires border crossing	No border crossing required
Voluntary	Involuntary

Why Arizona?

- Weather
- Major Sporting Events
 - Super Bowl, Phoenix Open, Spring Training
- Large trade shows and conventions
- Grand Canyon, Sedona, Scottsdale, Flagstaff, Tucson, Mesa, etc.
- Proximity to California, Las Vegas, and the US-Mexican border
- Easy access multiple interstates



"Victimless Crime"

80% of prostituted people report being trafficked in a hotel or motel on at least one occasion

Of girls18-24 years of age, 1 out of 3 homeless reported being trafficked

On average within 48 hours of being on the streets Arizona youth are contacted by a trafficker

Young boys and teenagers make up approximately 12-14% of the market

83% of sex trafficking victims are US citizens

Approximately 1/3 of all detected trafficking victims are children

The average age of a child first forced into sex trafficking is around 14.5 to 14.8 years old in Arizona

Trafficking Victims: Understanding Mindset

Frequently victims:

- Fear, distrust of people in authority positions such as social service providers, law enforcement, government officials
 - Fear of being deported or arrested
- Unaware what is being done to them is a crime
 - Do not consider themselves victims
 - They are often committing criminal acts-prostitution or other associated crimes



While there is no commonly accepted profile for victims of sex trafficking, certain populations are more vulnerable than others:


Sexual orientation



Branding

Tattoos or branding marks

- Script letters of a man's name, generally across chest/neck
- Use of the word "squares", mottos such as "trust and loyalty"
- Symbols such as money signs, guns, diamonds, etc.



INDICATORS

WARNING SIGNS FOR SEX TRAFFICKING

- •There are a number of indicators commonly found in instances of sex trafficking.
- •Note: many of those indicators can also be seen in lawful activities and the presence of just one of these
- •Indicators does not immediately mean sex trafficking is occurring. Incidents of multiple signs are the best indication.


Consider these to be red flags.





INDICATORS

- Presence of an overly controlling and abusive "boyfriend".
- Patron entertaining a young person at the bar or restaurant that they did not come in with originally.
- Patron requesting information or access to adult services or to local sex industry.
- Individuals exhibiting anxious or nervous behavior and avoiding contact with staff and other patrons.
- · Individuals loitering and soliciting male customers.
- Individual waiting at a table or bar and picked up by a male.
- Individuals without access to their own ID, cell phone, or money.
- Claims of being an adult although appearance suggests adolescent features.
- No freedom of movement or constantly monitored; avoids interaction with others.





INDICATORS



- Restricted, mediated, or controlled communication (not allowed to speak for self); answers seem coached.
- Averts eyes or does not make eye contact, especially with a "boyfriend".
- Lack of knowledge about current/past whereabouts; exhibits loss of a sense of time.
- Dressed inappropriately for age, has lower quality clothing than companions, or is wearing clothing inappropriate for weather conditions or surroundings.
- Appears to be with a significantly older "boyfriend" or in the company of older males.
- Treated in a demeaning or aggressive manner, or evidence of verbal threats.
- Individuals hanging out in lobby or hallways or appearing to monitor the area.
- Minor with patron late night or during school hours (and not on vacation).
- Group of girls traveling with an older male.
