The SEHOA communicates with homeowners in a number of ways. One communication channel is via the “What's Up” Newsletter. It is quite costly to print and mail newsletters via US Mail to all homes. Under the provisions of our newly adopted Declaration, we now have the option of communicating via electronic means (Section 15.6).
