Executive Board Meeting on May 16th at 6:30 PM

The next meeting of the Executive Board will be on Tuesday, May 16 at 6:30 PM at the Mountain View Fire Station at 8500 Niwot Road. All homeowners are invited to attend. The agenda and Zoom link will be posted on the SEHOA website (www.somersetestates-hoa.com) at least one day before the meeting. Tim Koller was appointed as a Director to the Board at the April 26th meeting, so we now have a full Board.

Niwot Loop Trail Completion Across Somerset Drive

Boulder County maintains a trail system called the Niwot Loop Trail that includes the path on the open space to the south of Somerset Estates and continues on in Legend Ridge. The only break in the "loop" is a small section across Somerset Drive and an outlot owned by SEHOA. An informal social trail through the grass connects the gravel trails on the two sides of the street (see photo). We have been in discussions with the County to complete the loop. This will include replacing the social trail with an actual trail, striping a crosswalk on the street, and extending the wood fence on the east side of the street (including replacing the current metal stakes). All costs will be borne by the County.

The project requires that SEHOA grant the County a license to cross its outlot. The Executive Board will consider approving a licensing agreement at the May 16 Board meeting. The proposed agreement, including a drawing of the

Pond 1 Nearing Completion

Pond 1 in Somerset is the entry point for ditch water for both Somerset and Somerset Estates. The pond has been completely reconstructed and is ready to

take ditch water as soon as it is released by the two ditch companies. The first water of the season is called river run and isn't counted against our water rights allocation. Both ditches are now full of water, so please be careful to stay away from them! Also, no recreational use (swimming, fishing, pets, etc.) is allowed in any of the ponds.
