

## Information for Buyers in Somerset Estates Updated April 12, 2024

**Somerset Estates Homeowners Association (SEHOA):** The Somerset Estates subdivision was one of two adjacent communities built in the 1980s and 1990s. For over 20 years these communities were managed as a single homeowners association. As a result of a court order in 2017 that determined Somerset Estates was a "separate and distinct legal entity", Somerset Estates Homeowners Association (SEHOA) was established in March 2018 to represent the interests of the 89 Somerset Estates homeowners.

**Architectural Control Committee (ACC):** Information about the ACC and the Architectural and Landscaping Standards can be found on the SEHOA website by navigating to the ACC tab. If you are contemplating any landscaping or exterior changes to the home you are purchasing, please review the Standards prior to your purchase. The ACC is also available and happy to answer any questions you may have.

**Financial Statements and Budget:** The current budget may be found by navigating to Library » Financials. The annual budget is ratified by the homeowners each March, with any dues increase taking effect on April 1. For 2024, the dues are \$825 per quarter. These funds are used to maintain the extensive common areas and associated irrigation system throughout the subdivision, as well as the administrative costs for SEHOA.

**Somerset Swim & Tennis Club (SSTC):** SSTC is a separate nonprofit corporation from SEHOA, and assessments paid to SEHOA do not cover SSTC membership.
