
# **ACC Survey Results**

The SEHOA Architectural Control Committee (ACC) recently distributed an information package via mail. It contained descriptive information about the Standards review process underway, a copy of the proposed Standards and a survey. We are grateful to the 26 households that responded to the survey representing 30% of all Somerset Estates homeowners. Complete survey results are posted on the website home page and also copied to the Library --> Downloads area. A summary of the combined results can be seen below. The ACC reviewed the survey results in detail and made final revisions to the proposed 2019 Standards.









Our thanks to the ACC for their ongoing work on this important project. We believe developing and applying updated Standards will help improve our community.

# **Remedial Landscaping**

For many years, we have lived with bare dirt on the north side of Somerset drive from Primrose to Longview. There are a number of reasons for this eyesore. A comprehensive solution will require considerable resources. In the meantime, the board has authorized "over seeding" in this area. You will see efforts underway in Spring. This is an initial step to restore some of the more obvious maintenance problems in our community. A more comprehensive approach will follow.

# **SHOA Tolling Agreement Proposed**

Certain aspects of clarifying water and land ownership matters for SEHOA depend on establishing arrangements with SHOA. As previously reported, we successfully negotiated a 2018 Memorandum of Understanding which, among other provisions, allocated cash assets held by SHOA and resulted in a payment of \$79,101 from SHOA to SEHOA to settle cash. SHOA subsequently agreed to a Limited MOU covering 2019. (These agreements are posted to the website.)

This May will mark two years since the 2017 court decision which recognized that SEHOA is a "separate and distinct legal entity". Some claims against SHOA could be subject to statute of limitations expiring on the second anniversary. We have proposed a Tolling Agreement to SHOA that would preserve the option of bringing action in the future if negotiations fail to resolve allocation questions. Our recent favorable experience dealing with SHOA gives us reason to believe we are on a path to resolve these matters amicably. We will make every effort to find solutions that do not require litigation which is costly and unpredictable.

#### **New Policies**

Our community operates in compliance with the Colorado Common Interest Owners Act (CCIOA), the state law governing HOA's. Last year, we adopted the 2018 Amended Declaration which further specified how our association operates. The Declaration and CCIOA require a number of policies to be adopted by the board. The board looked to other communities and modified policies found elsewhere to fit the needs of Somerset Estates. Many of these required policies have been adopted and are posted on the website (you will find them under Library --> Governing Documents). Several remain to be established.


