## 2020 Budget Ratified

The 2020 SEHOA Budget was ratified at the December 5th homeowner meeting. Thank you to the 28 homeowners that participated in the budget meeting this month. Ninety-three percent (93%) voted to approve ratification of the 2020 budget.

If you use an automated bill pay system, please adjust the amount of your quarterly dues payment to \$675, effective January 1.

The 2020 Budget reflects the board's commitment to control expenses while, at the same time, take meaningful steps to address deferred maintenance items, resolve open asset issues and, eventually, accumulate a reasonable reserve. This will take time, but will serve our long term common interests. **Thank you for your continued support!** 

#### Street Snow Removal

There was a heavy snowfall during the recent Thanksgiving week. For a period of several days, **only hardy residents at the wheels of four-wheel drive vehicles were able to get in and out.** Very inconvenient! Then we lived with compacted snow that turned to ice that could only be removed by heavy equipment.

Not surprisingly, we received anonymous homeowner inquiries asking **why the HOA can't hire private plowing company** to address the problem. It is a reasonable question and one that occurred to many of us.

First and foremost, the bylaws of the Somerset Estates Homeowner Association limits the scope of our activities to managing and maintaining the common property of the community. Unfortunately, **the streets are not a part of our common property** so we are constrained from spending resources to maintain property we don't own or control.

At this time, the inconvenience of waiting for the county to clear our roads doesn't justify accepting the risk of doing it ourselves. If poor snow removal becomes more serious, the HOA could acquire insurance to cover the risk exposure and indemnify the county in exchange for their permission. But even with that permission, the HOA would be taking on considerable liability.
