# Fence Maintenance Project Underway

As you may have noticed, damaged fence boards were replaced throughout the community and fences along Somerset Drive and Longview Drive are being stained. This will extend their life and give a more uniform look to these elements of our community. We expect completion of this phase later this week.

## **Pond Liner Issues**

If you recently walked the open space trail on the south side of our community, you may have noticed **the liner has failed on one of the ponds (Pond 8)**. This is one of 10 large and small ponds on SEHOA common property. These ponds were built by the developer of Somerset Estates between 20 and 30 years ago.

All these ponds are lined with an impermeable layer of PVC plastic and a damaged liner renders the pond unusable. These pond liners have a typical useful life of 20-25 years and the remaining useful life of our ponds were estimated to be 2-5 years when they were inspected in 2014 as part of a reserves analysis.

The liner that underlies Pond 8 began to fail last year and we performed an interim repair. While the repaired portion is intact, a board member that lives near the pond noted at the March 24 meeting that the remainder of the upper portion of the liner had completely failed as shown in the following photo:

Without an ability to operate Pond 8, there is a growing risk that Ponds 8-11 will become stagnant as temperatures rise. A sub-group of the board investigated and presented preliminary options at the April 14 board meeting. **The original installer of the pond liner provided a bid of \$120,000 to replace the liner and add protective material near the top.** An option to completely remove the liner and rework the area into a dry pond seeded with native grass was estimated at \$30-40,000, depending on the final design. Other bids and ideas are being solicited.

The Pond 8 situation was discussed at the May 12th board meeting and several homeowners who live adjacent to the south ponds attended to ask questions and provide input. The board postponed short-term action regarding Pond 8 to allow for further discussion and input.

In the meantime, a bubble has formed under the liner of Pond 7. The cause and possible solutions are not yet understood. As of this writing, water is being pumped from Pond 7 to other ponds so the situation can be assessed. The pond liner contractor will also assess SEHOA's eight other ponds to evaluate their current condition and remaining life.

Any discussion involving water in our neighborhood has many layers of complexity, involves high cost and has long-term implications. A special board meeting is scheduled for Thursday, May 21 at 7 pm to advance the discussion. The board remains committed to open and transparent decision making. Homeowners are always welcome to attend board meetings.

# **SEHOA Phishing Attack**

Since inception SEHOA has operated with the greatest amount of transparency as possible. In addition to holding periodic homeowner meetings and open board meetings, we post as much relevant information as possible on our website including minutes, newsletters, current events and email contact information for board members and the property manager. That information is open and available to anyone with computer access.

The downside of our openness has been greater exposure to spammers and hackers. As reported in a previous What's Up issue, the board received bogus messages trying to initiate payments to third parties. Similar attacks struck other HOA's in the area, so this appears to be a coordinated effort. We identified the unauthorized attempt and no monies were transferred.

In the last few days, a fraudulent email was sent which was made to appear as though it came from Marc Arnold at SomersetEstates-HOA.com, although it actually came from an outside email sender. It went to SEHOA board and committee members and may have gone to a limited number of SEHOA homeowners. The email asked for a Walmart gift certificate.

We trust that all recipients recognized the scam and that no one fell for this trick. We apologize for any inconvenience. If future phishing efforts grow, we may have to resort to security measures that restrict access to SEHOA contact information. For now, we will continue our open and transparent practices.
