# **Special Assessment Vote Under Way**

Funding our community's first Long Range Plan depends on the support of homeowners. The board approved a multiple choice Special Assessment and put it before the homeowners for ratification. Information packages and ballots were distributed to Somerset Estates Homeowners.

Ballots must be mailed by January 5th or hand-delivered by the 12th to be counted. Detailed instructions are contained in the information package. If you need a replacement ballot, please email info@SomersetEstates-HOA.com.

If you are out of town, you may still vote by assigning a proxy representative. Simply fill out and sign this proxy form and email to info@SomersetEstates-HOA.com, and we will get a ballot to your proxy. Please pick someone in Niwot and tell them how you would like for them to vote on your behalf.

As ballots return through the mail, they will remain sealed in the "secret ballot" envelope until the January 12th Board meeting, so we won't know until then which of the Special Assessment options is favored. We will, however, know which addresses are represented as the votes come in. **Signs throughout the** 

neighborhood reflect the number of votes cast street-by-street to encourage community involvement.

# **Anonymous Feedback**

From time to time, the board receives anonymous feedback by means of the "Anonymous Survey" link posted at the bottom of every What's Up newsletter. **Homeowners are invited to share their thoughts at any time.** Here is a recent example of a message sent to the board through this mechanism:

"I'd like to thank the board for the great work they do, and specifically with the recent financial analysis of our long range budget. It is clear that the many years of under funding Somerset Estates has left us in a worrisome condition. This is a beautiful community of high end homes, but without funds to maintain (no less improve!) common property, the value of our properties and the pleasure of living in a well maintained environment can not be sustained. Due to the age of the infrastructure, we need funds to take care of the costs of expected, as well as unexpected costs.

I, therefore, would gladly pay an assessment to bring us into good standing relative to our budgetary needs. At the last meeting, where this assessment was discussed, the board recommended a \$5,000 assessment. I think that number is way too low. Per my understanding of the plan the board laid out, I think a \$15,000 assessment would bring us to a healthy level. I think that we all deserve

to know that the value of our homes will not be diminished by having low reserves, and I would hope my neighbors would agree to step up to preserve the outstanding community we we share."

#### **Executive Board Vacancies**

Mike Sims and his family will be moving away soon. Mike therefore withdrew from the Executive Board. We are grateful for Mike's excellent contribution to the community and wish him and his family well.

A request for a volunteer Board member to fill the vacancy went out to the neighborhood. Scott Abrahamson kindly volunteered and was appointed to serve out the remainder of Mike's term at the recent November 17th Board meeting. Welcome aboard, Scott!
