Crime Response Update

As previously reported, a private security company is patrolling our neighborhood and the Niwot Loop Trail parking lot off 79th St. In addition, a task force consisting of Gayle Becker, Beth Ryan, and Erin Sharp is working with the Sheriff's Office and other experts with the goal of making recommendations to the Board about additional actions, such as camera systems.
