FEO RUNS (For exhibition only) ARE OFFERED AT THESE TRIALS.

Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds

All entries, requests for move-up, etc. are promptly responded to. If you do not receive a response within 48 hours during the work week, please email Shannon.

Express mail entries must include the signature waiver allowing them to be left at the secretary's address (max 10 entries per envelope). No entry shall be made, and no entry shall be accepted that specifies any conditions as to its acceptance. **No entries will be accepted by phone, fax or email.**

Payment must accompany entry. No hand deliveries will be accepted in the first twenty-four hours following the opening date and time. Inquiries may be directed to Shannon Jones at firstdobe@gmail.com.

Entries must be submitted on Official AKC-form with correct entry-fees listed. One dog per form. **Please read the section: "Class changes effective January 1, 2020," posted in the premium, for instructions when entering same dog in multiple heights or mixed regular and preferred classes.**

Agreement on back of form **MUST** be signed. Photo-copies must be legible with original signature. Max 10 entries (dogs) per envelope (includes Express-mail-entries). **NO emailed forms, fax or telephone entries accepted.**

Illegible entries will not be processed and will be returned to the exhibitor. **Returned checks do not constitute a valid entry and the Trial Secretary will add a \$30.00 collection fee to the amount of each returned check.** Be sure to include correct fees. Overpayments less than \$10 will not be refunded

This trial is accepting online entries through LabTestedOnline.com. During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows. 30% online per day, 70% each day. If either form of entry has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either one accordingly.

MEASURING AND HEIGHT CARD INFORMATION

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the Judge of Record PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 24C height division. However, if a Volunteer Measuring Official (VMO) or an Agility Field Rep is present; ALL dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog before its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

PLEASE NOTE:

Effective 1/2/18, the 26-inch jump height division is replaced by the 24-Choice jump height division.

RINGSIDE - Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

MIXED HEIGHT ENTRIES

A separate entry form must be submitted when the same dog is being entered in different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1st run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

ENTRY REQUIREMENTS FOR INTERNATIONAL SWEEPSTAKES CLASSES (ISC)

Purpose: The International Sweepstakes Class (ISC) is a non-regular class providing the dog and handler an opportunity to demonstrate their advanced training and handling skills on various International Style Standard and Jumpers with Weaves courses. The rules for this class are generally based on international rules. The variety in International Agility course designs is very diverse, so handlers should be prepared to meet the "Challenge of the Day" when competing in the ISC class. The total challenge level may be easier, more difficult, or simply different from what is currently allowed in Excellent / Master Class. Complete rules for the ISC are available from the AKC Website (<http://www.akc.org>).

Eligibility: ISC classes are open to dogs that are eligible to compete in AKC agility trials. There is no Preferred Option for ISC; dogs may enter at their preferred jump height, however they will be scored against the regular division dogs jumping the same jump height.

Jump Heights:

DOGS MAY BE ENTERED IN THEIR REGULAR JUMP HEIGHTS, however, only those dogs running in the 12", 16", 20" and 24" class that meet the FCI/ISC measuring cutoff (different than regular AKC cutoffs) may use their clean run toward the required qualification toward entering WTT or EOTT. Please see the 2022 EO/AWC Tryout Rules for further details. The FCI/ISC cutoffs for those heights are as follows:

- Small (12" jump height) – for dogs measuring 13 ¾" or less at the withers
- Medium (16" jump height) – for dogs measuring more than 13 ¾" and up to 16 7/8" at the withers
- Intermediate (20" jump height) – for dogs measuring more than 16 7/8 but less than 18 7/8" at the withers.
- Large (24" jump height) – for dogs measuring over 16 7/8" at the withers

WAIT LIST

A waiting list will be maintained for these trials once they have closed on October 17, 2024. The waiting list will be active until its deadline - Monday, October 21 at 6:00 pm. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed for the number of runs replaced. If a run is pulled, but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent from the run. Entry fees for runs on the waiting list that do not get into the trial by the waiting list closing date, will be refunded in full.

SITE INFORMATION

Rising Star Canine Ranch is a climate-controlled indoor facility with one 100 x 150 foot rings with an artificial turf surface.

The grounds will be available for crating for all exhibitors at 7:00am on each morning.

Due to limited space, large reclining chairs will NOT be allowed in crating areas.

All dogs must be on leash at all times except when in the ring or the designated warm-up area.

Bottled water will be available, and there is a filtered water dispenser in the building. You may want to bring a refillable water bottle (or bring your own bottled water).

The Triangle Agility Group of North Carolina and Rising Star Canine Ranch will not be responsible for any lost or damaged items left at the show site.

OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. Rubberized contacts will be used. All classes will take place on an artificial turf surface. Ring size will be 100' x 150'.

Course WALK-THROUGHS AND Warm-Up INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only.

A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

AKC RULES AND REGULATIONS

All exhibitors should obtain a copy of the Regulations for Agility Trials by downloading them from the American Kennel Club website at <http://www.akc.org/rules/>.

NOTICE TO EXHIBITORS

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any entry fees will be made. All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. No dogs may be left tied to trees, cars, fences, etc.

Dogs under 4 months of age are not allowed at this trial. Entry fees will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reason of civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. Exhibitors are responsible for being at the ring gate when it is their turn to run. No classes will be held up by a late exhibitor.

This club does not agree to arbitrate claims as set forth on the Official AKC Entry Form for this event.

BIS, AND INJURY REFUND INFORMATION

Any exhibitor with a bitch entered, which is in season on the trial date, will be refunded their full entry fee. Please inform trial secretary as soon as possible. If bitch comes into season during the actual trial or between trial days, please advise trial secretary. Any classes that are affected will be reimbursed.

Injury/Illness – Dogs that cannot compete prior to the set of trials due to an injury/illness will be refunded the entry fee, less \$5.00 per run, upon written certification from a veterinarian. Notification with documentation from veterinarian must be in the hands of the Trial Secretary no later than 30 minutes before the start time on Thursday October 24, 2024. Validation of the injury/illness must be made by a licensed veterinarian. Requests from chiropractors, massage/physical therapists, etc will not be accepted. Handler illness/injury is excluded from this policy.

RIBBONS AND AWARDS

- ❖ Flat ribbons will be awarded to the first through fourth place dog in each jump-height division in each class.
- ❖ Qualifying ribbons will be awarded to all dogs receiving a qualifying score
- ❖ Special awards will be given for winners of the ISC Classes and overall winners of the ISC Cup

All ribbons and awards must be claimed by the end of the Trial; none will be mailed.

VOLUNTEERS

We need your HELP for a Successful Trial!

Once again, we are counting on the generosity of agility enthusiasts to pitch in and help keep the trial running smoothly and efficiently.

Those of you who are experienced can help us by sharing your talents and helping to train the newcomers. For those of you who are new to agility, we will train you and offer support as you learn about what it takes to put on a trial.

We will make sure your duties will not interfere with running your runs.

FEO (FOR EXHIBITION ONLY) AND FIX AND GO ON

Entering For Exhibition Only (FEO) FEO allows exhibitors to work with their dogs in a trial environment. FEO is now offered in all classes. Participation in FEO is non-qualifying and the exhibitor will be marked ABSENT in the final official catalog.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of any class. If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring. Toys must be non-audible and may not leave the handlers hand. Toys that roll freely may not be used.
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

Fix and Go On FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

Take exit 201 toward Union Cross Road, continue 4mi. Continue on Main St (NC-150) for .6mi, turn right onto N Main St (NC-150) and continue 6mi (turns into Oak Ridge Road). Turn left onto NC-68N for 2.8mi, turn left onto Haw River Road for 1.5mi, turn left onto West Harrell Road for 1mi.

From the north/east: I-85S to I-40W toward Greensboro. Take exit 210 onto NC-68 toward airport. Continue for 10mi, turn left onto Haw River Road for 1.5mi, turn left onto West Harrell Road for 1mi.

From the west: I-40E toward Greensboro. Take left exit 188 onto US-421S toward Winston-Salem, continue for 15.8mi. Take exit 222 NC-150 toward Kernersville, then turn left onto NC-66S for .8mi, then turn right onto N Main St (NC-150) and continue 6mi (turns into Oak Ridge Road). All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
