If you need a paper confirmation and would like to know the status of your entry prior to the issuance of the judging schedule upon closing, please enclose a self-addressed, stamped envelope or postcard along with your entry.

All entries, requests for move-up, etc. are promptly responded to. If you do not receive a response within 48 hours, please email Shannon. (weekends excepted).

Express mail entries must include the signature waiver allowing them to be left at the secretary's address (max 10 entries per envelope). No entry shall be made, and no entry shall be accepted that specifies any conditions as to its acceptance. **No entries will be accepted by phone, fax or email.**

Payment must accompany entry. No hand deliveries will be accepted in the first twenty-four hours following the opening date and time. Inquiries may be directed to Shannon Jones at firstdobe@gmail.com.

Agreement on back of form **MUST** be signed. Photo-copies must be legible with original signature. Max 10 entries (dogs) per envelope (includes Express-mail-entries). **NO emailed forms, fax or telephone entries accepted.**

Illegible entries will not be processed and will be returned to the exhibitor. **Returned checks do not constitute a valid entry and the Trial Secretary will add a \$30.00 collection fee to the amount of each returned check.** Be sure to include correct fees. Overpayments less than \$10 will not be refunded

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Females in season may not participate, aggressive dogs, or dogs suffering from an injury, or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

SITE & TRIAL INFORMATION

- There will be TWO scent work trials held on each day. Entries are limited to 8 hours of judging per judge per day.
- **No Exhibitor Setup prior to Friday.**
- **Current plan is for car crating, however if weather does not allow this due to extreme cold, an indoor crating area will be worked out.**
- **Masks** are optional for all individuals.
- **Trial Site.** It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments, and such visits may risk the host losing the opportunity to use the location in the future. This trial site will not be used for Scent training one week before the trial.
- **Possession of Odors and Training.** Chapter 5. Section 26 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".
- **Spectator Area.** Spectators are encouraged. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run except in the case of Handler Discrimination classes. No one outside the search area may assist the handler or disclose the location of the hide. Spectators who intentionally or unintentionally give aid to a team may be asked to leave the area by the judge. Spectators are forbidden to discuss details of the search with handlers who have not run. Please do not discuss any searches while on trial grounds to avoid any confusion.
- Exhibitors are responsible for **cleaning up after their dog(s)**. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.
- Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Bitches in season, aggressive dogs, or dogs suffering from an injury or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.
- By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely.

TRANSFERS (MOVE UPS)

A move-up transfer may be requested if, according to the owner's records, the handler and dog are eligible and the dog has completed the requirements for the title after the closing date of the trial in which the entry has been made. A move-down transfer may be requested if the owner mistakenly entered the dog in a higher level class for which the dog is not eligible. A lateral transfer may be requested if the owner mistakenly entered the dog in Novice A and the dog is not eligible.

Transfers (including transfers between an "A" and "B" class at the same level) must be made in writing and must be received by the Trial Secretary in accordance with the applicable AKC Regulations. For transfers made prior to December 20, 2024, emails will be accepted as long as the email includes the dog's call name and AKC registration number, owner's name, original class entered, and new class requested. For transfers made at or on the days of the shows, the request must be made on AKC approved forms which are available online at the AKC's website, http://images.akc.org/pdf/events/Scent_Work_Transfer_Form.pdf, as well as from the Trial Secretary.

BIS, AND INJURY REFUND INFORMATION

Any exhibitor with a bitch entered, which is in season on the trial date, will be refunded the entire entry fee. Notification must be made to the Trial Secretary no later than 30 minutes before the start time each day. If your bitch comes into season during the trials, please advise the Trial Secretary as soon as possible and all remaining classes will be refunded.

Injury/Illness – Dogs that cannot compete prior to the set of trials due to an injury/illness will be refunded the entry fee, less \$5.00 per run, upon written certification from a veterinarian. Notification with documentation from veterinarian must be in the hands of the Trial Secretary no later than 30 minutes before the start time on Friday, December 20, 2024. Validation of the injury/illness must be made by a licensed veterinarian. Requests from chiropractors, massage/physical therapists, etc will not be accepted. Handler illness/injury is excluded from this policy.

WAIT LIST

A waiting list will be maintained for these trials once they have closed on December 13, 2024. 30 runs per trial will be held on a wait list for entry into the trial. Full refunds will be given to withdrawn entries replaced by a waitlisted entry, and all waitlisted entries not accepted into the trial.

SEARCH AREA, STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Search areas may be of any shape, and of the size specified in the Regulations for each class. Searches may be indoors or outdoors, on matted, carpeted, tiled, dirt, or cement surfaces. Trial will take place rain or shine. Search area sizes will be as stated in the AKC regulations for all elements and levels.

Staging Area will be out of view of search area(s). Staging area will include warm-up and waiting areas.

The **Handler's Briefing** may take place in view of the search area prior to the start of each class*, after the hide(s) have been set and after the Demo Dog has run. In the handler's briefing the judge will explain if there is an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the handler's briefing. *This may be modified per AKC Best Practices.

A **warm-up** area will be available consisting of ONE marked container of each odor being tested at the trial and may also consist of blanks containers. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior to their run, or for recovery after the run. The warm-up area is not for training or relieving of the dog. Please be considerate of others using the area.

NOTICE TO EXHIBITORS

A preliminary confirmation will be sent once your entry is received. A final confirmation with trial details will be sent out about a week before the trial.

SAFETY, BEHAVIOR, AND LIABILITY

The **safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Carolina Piedmont Agility Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Carolina Piedmont Agility Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Carolina Piedmont Agility Club or any official thereof.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge (tags ok). Dogs are permitted to have a wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. Details about flow and run order progression will be covered in the briefing.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

Exhibitor Check-In At check-in you will receive your armband number. Once the time and location for check-in is determined all exhibitors will be notified by email. Exhibitors **MUST** check-in for EACH for trial they are entered.
