The Greater Connellsville Chamber of Commerce welcomes you to the 2025 Farmer's Market season. We are looking for vendors ranging from artisans to farmers to makers to food vendors. We are seeking plants, produce, honey, eggs, soaps, and other homemade items.

For the 2025 season, the markets will take place every week, Thursday, starting June 5th and ending on August 21st. All markets will be 5 PM - 8 PM. Vendors may set up an hour prior. The markets will take place at the East Side Fire Station, 200 N Arch St, Connellsville, PA, 15425 - using Arch Street between Peach and Apple Street to set up.

Indoor and/or Electricity Use: Limited availability. Must be reserved ahead of time. Please see attached application for details. Below is the vendor pricing and please see attached vendor form. We are working with local businesses to have sponsors for the farmer's market which would enable us to give away "market bucks" to spend with our vendors.

Vendor Season Pass - \$150 non-chamber, \$100 chamber members

- Payments must be made in advance
- Season pass vendors will have an assigned space
- Vendors are not permitted to miss more than 3 times per season or their assigned space will be forfeited

Vendor Weekly Pass- \$20 per market non chamber member, \$15 per market chamber member

- Cash Only
- Payments accepted at each market
- First come, first serve

Food Vendor- \$50 per market

- Must book and pay in advance, first come, first serve. One food truck per market.
- Limit 2 markets per food vendor (more markets may be added if needed to fill vacant spots)
- Must have all necessary registrations, licensing etc.

Rules & Regulations

- Weekly vendors are on first come, first serve basis
- All foods must be properly labeled
- No outside alcohol is allowed in the area without prior authorization and necessary permits.
- Vendors are responsible for any applicable taxes
- Vendors are responsible for cleaning and removing all trash from the area at the conclusion of the event.
- Vendors may set up one hour prior to the market start and must stay set up until the end of the market. No early breakdowns.
- Vendors must provide their own tables, tents, chairs, extension cords, and/or power strips.
