If an illness or situation prevents a photo session from taking place, client may reschedule their session at least 24 hours prior to their shoot. Digital Negatives, Prints and Copyrights

Photographer retains the copyright to all photos and images produced. The Client may buy a copy of the digital photographs on a USB. If so, the Client may reproduce any images in any manner they like for sharing and enjoyment of friends and relatives. It cannot be edit or Sell the Images. Please Initial _____

The Client hereby grants to the Photographer and its legal representatives and assigns the right to use and publish photographs of the Client, Images may be included, for editorial & advertising, Please Initial _____

Retention of Delivered Files.
