# Reservation

Upon your signature, the Photographer will reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the Retainer of \$100.00 is non-refundable, even if the date is changed or cancelled for any reason. The Deposit is to be paid at time of signing the contract. ## Rescheduling

If an illness or situation prevents a photo session from taking place, client may reschedule their session at least 24 hours prior to their shoot. Photographer reserves the right to reschedule due to illness, weather, equipment malfunction, or other circumstances beyond their control. *Initial* 

## **Digital Negatives, Prints and Copyrights**

Photographer retains the copyright to all photos and images produced. The Client may buy a copy of the digital photographs on a disc or USB. ### **Retention of Delivered Files.**

Once the JPEG files are delivered to the client, it is the client's sole responsibility to protect and retain their images for the future. It is highly recommended that CD be duplicated and stored in multiple locations that are cool and dry. (Technology can be fickle; one of the best ways to ensure the client's images will last for generations is for the client to print them or on a Canvas.) If client requires old files to be duplicated by the photographer, and they are still within the photographer's possession, a restocking fee will be applied. (\$99.00)
