AGREEMENT/ TERMS AND CONDITIONS.
Purpose
This agreement contains the entire understanding between the Photographer and the Client. It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing, signed by all the parties. <i>Initial</i>

Digitals or other products

The Client can decide whether to buy any Images the day of booking & signing the contract, or wait until viewing your Online gallery. <i>Initial</i>
Payments: The Client agrees that the Reservation / RETAINER of \$100.00 ( Non-refundable ) is required at the time of signing the contract. The Outstanding Balance is due THE DAY OF SESSION. Initial
Travel Fees
50 cents per mile after 25 miles out of Park Rapids. (Round trip) Initial
Reservation
Upon your signature, the Photographer will reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the Retainer of \$100.00 is non-refundable, even if the date is changed or cancelled for any reason. The Deposit is to be paid at time of signing the contract. It is applied towards the contracted Session Fee. <i>Initial</i>
Rescheduling
If an illness or situation prevents a photo session from taking place, client may reschedule their session at least 24 hours prior to their shoot. Photographer reserves the right to reschedule due to illness, weather, equipment malfunction, or other circumstances beyond their control. <i>Initial</i>
Digital Negatives, Prints and Copyrights
Photographer retains the copyright to all photos and images produced. The Client may buy a copy of the digital photographs on a disc or USB. If so, the Client may reproduce any images in any manner they like for sharing and enjoyment of friends and relatives. It cannot be edit or Sell the Images.  **Initial**
Model Release
The Client hereby grants to the Photographer and its legal representatives and assigns the right to use and publish photographs of the Client, Images may be included, for editorial & advertising.  **Initial**

## **Retention of Delivered Files.**

Once the JPEG files are delivered to the client, it is the client's sole responsibility to protect and retain their images for the future. It is highly recommended that CD be duplicated and stored in multiple locations that are cool and dry. (Technology can be fickle; one of the best ways to ensure the client's images will last for generations is for the client to print them or on a Canvas.) If client requires old files to be duplicated by the photographer, and they are still within the photographer's possession, a restocking fee will be applied. (\$99.00)
