### **Reservation/ Retainer**

Upon your signature, the Photographer will reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the Reservation **Deposit of \$600 is non- refundable .** Even if the date is changed or wedding cancelled for any reason, including acts of God, Fire, strike, and extreme weather. The Reservation Deposit is to be paid at time of signing the contract. The Reservation Deposit is applied towards the contracted Wedding Package. \_\_\_\_\_ **Please initial**

### **Pre-Event Consultation**

The parties agree to a pre-event consultation before the Wedding Day in order to finalize the actual shooting times, locations, and Client's request list (in writing) for specific photographs. The Client will be responsible for, or have someone designated, to identify people of whom specific photographs are desired. The Photographer shall not be held liable for failure to take desired photographs. \_\_\_\_\_ **Please initial**

### **Food/Breaks**

The photographer (s) will be allowed one 20 minute break at their own discretion, and bathroom breaks when necessary. Photographer will be provided a full guest meal/or Snacks for weddings longer than 4 hours. If no meal is provided, the photographer(s) reserves the right to go off-site for a meal for 30 minutes. \_\_\_\_ **Please initial**

### **EXCLUSIVE PHOTOGRAPHER:**

Flo Bretz shall be the exclusive photographer retained by the Client for the purpose of photographing the event. Guests, family, friends of the Client can photograph as long as they do not interfere or get in the way of the Photographer's duties. It is highly recommended by The Photographer for Clients to consider an **"Unplugged Ceremony"** where cell phones, and other cameras are not allowed. The perfect way for all your guests to be completely present. \_\_\_\_ **Please initial**

### **Digital Negatives, Prints and Copyrights**

Photographer retains the copyright to all photos and images produced. The Client may receive a copy of the digital photographs on a USB , agreed upon as part of the Wedding Package. If so, the Client may reproduce any images in any manner they like . **\_\_\_ Please initial**

### **Model Release**

The Client hereby grants to the Photographer and its legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of the Client and Guests, or in which the Client and Guests may be included, for editorial, trade, advertising, and any other purpose and in any manner. to alter the same without restriction; and to copyright the same. The Client hereby releases the Photographer and his legal representatives and assigns from all claims and liability relating to said photographs. **\_\_\_ Please initial**

### **Retention of Delivered Files.**

Once the JPEG files are delivered to the client, it is the client's sole responsibility to protect and retain their images for the future. It is highly recommended that you stored it safely. (Technology can be fickle; one of the best ways to ensure the client's images will last for generations is for the client is to print them.) The Photographer will keep your images for 12+ months after the Flash drive is delivered. After few months, there will be a \$100 fee to retrieve them for any reason. Please back up your photos onto a flash drive, external hard-drive, or online cloud storage. **\_\_\_ Please initial**

### **Payments**

The Client agrees that the Retainer/ *Deposit of \$600.00 is required at the time of signing the contract* and the Outstanding Balance is due two (2) weeks before the Wedding Day. **\_\_\_ Please initial**

### **Destination Weddings**

Destination or OUT OF TOWN Wedding . If travel is required for the Photographer, the Client is responsible for ALL AIRLINE EXPENSES + (2) NIGHT accommodations and (2) transportation expenses. The Photographer will book her own accommodations & will let the client know the COST . In most cases, the Photographer is more than happy to stay in the hotel where the Client has reserved rooms for out-of-town guests.      **Please initial**

### **POST PRODUCTION and EDITING:**

The final post production and editing styles, effects, and overall look of the images are left to the discretion of Flo Bretz . The Client(s) give artistic licensing to The Photographer.. FLO will edit images as she sees fit. Under no circumstances can Clients or anyone from their party alter, edit, add filters, or crop any images taken by Flo Bretz.      **Please initial**

### **Non-Guarantee**

Although every possible care will be taken to produce photographs of all important and special moments during the wedding, the Photographer cannot place an unconditional guarantee on the above. The Photographer will not be held responsible for any ruined photographs due to guests' (or any other) Flashes; or any other ruined photographs due to any other cause in or outside of the Photographer's control .      **initial**

### **DAY OF COORDINATION:**

It is helpful to appoint a "photo coordinator" to gather family, friends, or guests of importance for formal portraits. If The Client wants sunset/golden photos, but the day is rainy or the timeline got out of control and portraits weren't done until after the sun went down, then the golden light photos aren't going to happen. It is recommended that The Client and The Photographer talk about a timeline that will suit everyone so that the chances of missed photos or time is lessened.      **Please initial**
