ELEVATED ENERGY EXCHANGE TERMS AND CONDITIONS

REGISTRATION

All participants are required to have a complete registration form on file. Updates must be made for any changes, such as phone numbers, emergency contacts, etc.

SERVICE PAYMENTS AND FEES

All payments and fees are due prior to any services being rendered. All classes and sessions must be scheduled and booked online. Reservations and walk-ins cannot be guaranteed, and are allowed based on availability. Group classes must be canceled one (1) hour prior to the scheduled class. Payment and fees are non-refundable and non-transferrable.

Monthly Membership

Monthly memberships are due on the same date each month. If signing up on the last day of the month, payment is due on the last day of each month. Any dues that are not paid within 5 days of the due date will incur a 10% late fee. Memberships must be canceled 14 days prior to the next due date. In order to secure the membership rate at the time of registration, no lapse in membership must occur.

Class Passes

Class passes must be used within a month of purchase. The ten (10) class pass can be shared within a family household (the two adults and children / teens listed on the registration form).

YOUTH MEMBERSHIP AND CLASS ATTENDANCE

All participants are required to have a membership or class pass to attend any classes.

Ages 5-12

Children can attend family classes, and must be accompanied by a parent / guardian.

Ages 13-17

Teens are able to attend any of the classes, unless designated for adults only. Teens must be dropped off and picked up by any person listed on the registration form. A picture ID will be required. A written notice by the parent / guardian must be given if someone other than those listed will be picking up the teen. Teens are able to check themselves in and out with parent / guardian permission.

PRIVATE SESSIONS

Private sessions are provided by independent contractors.

ELEVATED ENERGY EXCHANGE WAIVER OF LIABILITY

Elevated Energy Exchange endeavors to provide a safe environment and programs for you, your family and guests. Elevated Energy Exchange provides exciting, life-enhancing programs that involve exercise, learning, and sports. These programs, however, necessarily have a certain amount of risk associated with them. The purpose of this Agreement is to secure your agreement to assume these risks, on behalf of yourself and any children or other minors for which you are legally responsible, and to ensure you are aware of and adhere to certain Elevated Energy Exchange safety and other policies.

ASSUMPTION OF RISK AND RELEASE OF LIABILITY

I acknowledge and agree that use of any of the Elevated Energy Exchange facilities, services, equipment or premises (the "Facilities") necessarily involves risks of injury to my person and property, and to the person or property of any child or legal ward of mine (hereinafter "dependents") that I have requested or allowed entry to or use of the Facilities. By engaging in such use, or permitting use by a dependent, I voluntarily accept and assume full responsibility for these risks.

In consideration of the use of the Facilities, I agree that Elevated Energy Exchange and its directors, officers, members, employees, volunteers, and agents (collectively, the "Elevated Energy Exchange") will not be liable for any injury to my person or property or to the person or property of any dependent of mine.

Further, on behalf of myself and my legal successors, I do hereby release, discharge and hold harmless Elevated Energy Exchange from any and all liability and claims arising from my use, or use of a dependent of mine, of the Facilities. I further covenant not to sue Elevated Energy Exchange with respect to, and I waive any and all claims that I may have now or in the future against, Elevated Energy Exchange for any liability arising from the use of the Facilities. This waiver includes, but is not limited to, all liability and claims arising from personal injury (including death), accidents or illness and damage to, loss of, or theft of property. I understand that, notwithstanding the foregoing, should I sue or file any claim against Elevated Energy Exchange, or threaten to sue or file any such claim, the Elevated Energy Exchange may terminate my membership privileges and my involvement in any program or activity of the Elevated Energy Exchange.

BY SIGNING AT THE BOTTOM OF THIS AGREEMENT, I UNDERSTAND I AM RELEASING **ELEVATED ENERGY EXCHANGE** FROM ALL LIABILITY TO ME, AND MY DEPENDENTS, FOR ANY AND ALL LOSSES AND DAMAGE TO ME OR SUCH DEPENDENT, AND I FOREVER GIVE UP ANY CLAIMS THEREFOR ON ACCOUNT OF INJURY TO PERSON OR PROPERTY, WHETHER CAUSED BY THE NEGLIGENCE OF **ELEVATED ENERGY EXCHANGE** OR OTHERWISE.

FOR YOUR HEALTH

It is my responsibility, prior to engaging or permitting any of my dependents to engage in any exercise program or other activity involving physical activity, to consult with my physician to determine whether I and my dependents are medically able to engage in the program or activity. It is my responsibility to monitor my own condition and those of any dependents throughout any activity and, should any unusual symptoms occur, to cease participation and inform the Elevated Energy Exchange staff of the symptoms.

I give permission to any Elevated Energy Exchange staff person to administer first aid in the event of an emergency and to summon 911 response units for any medical treatment needed for me and my dependents. I understand that the staff will try to phone the emergency contacts in my Elevated Energy Exchange household record, but is not required to do so before action is taken. I agree that any medical expenses incurred by me or my dependents will be my responsibility.

FOR YOUR SECURITY

I understand the Elevated Energy Exchange premises, parking lots and locker rooms are provided for members' and guests' convenience while participating in Elevated Energy Exchange programs. The Elevated Energy Exchange is not responsible for vandalism, break-ins or thefts of personal property. I understand the Elevated Energy Exchange recommends that valuables should not be brought to program activities or onto any premises. I agree to report any suspicious activity immediately to the staff. I understand that it is my responsibility to request, read, and after enrollment abide by the refund, cancellation and fee payment policies connected to specific membership and program involvement.

YOUR CONDUCT

I and my dependents will not bring weapons, controlled substances or alcohol on Elevated Energy Exchange premises. I understand that any form of solicitation is prohibited, and the use of violence, noise, force, coercion, sexual misconduct, threats, intimidation, unsafe conduct regarding children, fear, resistance, insults, or other conduct, intentionally or unintentionally causing disruption or preventing Elevated Energy Exchange members' ability to enjoy their program activities, membership or Elevated Energy Exchange staff's and/or volunteer's ability to conduct class or their job duties, is not acceptable behavior, is in conflict with Elevated Energy Exchange values, and may result in my or my dependent's program withdrawal or termination. I am aware that the Elevated Energy Exchange reserves the right, within its sole discretion, to withdraw program involvement and membership privileges to anyone for any reason that the Elevated Energy Exchange, in its sole discretion, considers appropriate or in the interests of the Elevated Energy Exchange and/or its patrons.
