# STANDARD STUDIO ETIQUETTE & POLICY

Academy students find great joy in learning the art of classical ballet. Our faculty encourages the use of "studio etiquette"; we nurture a wonderful studio learning experience by showing respect and gratitude to classmates and instructors. With your help, we will continue to develop an accomplished group of dancers.

- Please no food or drink, candy or chewing gum in the studio/ dance space. Water bottles are acceptable in the studio.
- No running or hanging on barres in the studio.
- Students should enter the studio/ dance space only after the instructor has invited them.
- Entering the studio during class time causes disruption to the pace of the class and progress for all students We ask parents & guardians to remain outside the ballet studio while their child's class is in session.
- Only registered students allowed in studio space. Please no siblings as participants or observers.
- Offices and wardrobe/prop closets are for staff use only.
- Students are required to wear designated class attire.
- Students should arrive on time for class. Young students should not be left unattended prior to their class beginning.
- Arrive on time for the start of class. Class participation with improper warm up could result in injury.
- Students are asked to remain in the school lobby and not outdoors while waiting for rides. Prompt retrieval of your child will ensure his/her safety.
- We love seeing your children each class. A student's consistent class attendance will allow for strength in training and progression to the next level. Make up times for missed classes are always available. Ask about make up class day and time.
- Pointe shoes are every dancer's goal & we will get you there. Teachers evaluate students throughout their training, and at the appropriate time for pointe shoes. The academy offers pointe classes to students who have receive supervised preparation for *pointe* work.
- New students are encouraged to try a lesson before enrolling. Intermediate & upper-level students are invited to attend a placement class before enrolling.
- An alternate class date/ make up class is always available for missed classes. Ask for a make-up day!
