forever discharge jet ski Owner, jet ski Owner's agents, servants, successors, heirs, executors, administrators and personal representatives, of and from all, and all manner of, actions, causes of action, suits, proceedings, debts, dues, contracts, judgments, damages, claims, and demands whatsoever in law or equity, which Renter ever had, now has, or which Renter's heirs, executors, administrators or personal representatives hereafter can, shall, or may have for or by reason of any matter, cause, or thing whatsoever arising out of this Agreement; out of the use (misuse, or abuse) of the jet ski; or in any way arising out of the rental relationship between Renter and jet ski Owner.
3. The Renter will be legally responsible and responsible for all medical bills
for anyone injured while utilizing the rental, including loss of limb or life.
5. I,, have been explained how to run the jet ski, start the jet
ski, locate and monitor fuel, how to refuel, how to monitor battery, how to park, and how to moore.
6. I,, have been shown the emergency devices: fire
extinguisher and whistle. I have also been shown the SC vessel certification card that I will need to produce if should be stop on the lake.
7. I,, understand that I am also fully financially responsible if I
damage any boat/jet skis, watercrafts, docks or other property while utilizing the Rental.
8. I,, understand and promise to adhere to state law regarding
the use of life jackets. All persons must wear a life jacket at all times while on the Jet
Ski. All persons must wear life jackets while swimming from the Jet Ski.  9 I understand that if I break any of the rules outlined in the manual, I will
immediately forfeit the remainder of my stay on the Jet Ski and will not receive any
refund. There are no refunds for any reason.
10 I understand that I am responsible for any damage to lake property,
businesses, or watercraft that I damage while operating and renting the Jet Ski.

No effect is given to any choice-of-law or conflict-of-law provision or rule (whether of the State of South Carolina or any other jurisdiction) that would cause the application of the law of any jurisdiction other than those of the State of South Carolina

Entire Agreement. This Agreement constitutes the sole and entire agreement of its parties with respect to the Agreement's subject matter. This Agreement supersedes all prior and contemporaneous understandings, agreements, representations, and warranties with respect to the subject matter. As between or among the parties, oral statements or prior written material not specifically incorporated in this Agreement have no force or effect. The parties specifically acknowledge that, in entering into and executing this Agreement, each is relying solely upon the representations and agreements contained in this Agreement and no others.

## **Booking and Cancellation Policies for Jet Skis**

- Changes to reservation times or dates must be made 14 days prior to your scheduled rental date.

- In the case of dangerous weather such as, tornado warnings, heavy rain lasting more than 45 minutes, or lightning on the day of your rental, credits toward a future rental or a refund may be issued. Any cancellations or rescheduling must be based on actual weather conditions at your arrival time and cannot be determined based on preliminary forecasts.
