1 The Court having reviewed the Tenth Application for Allowance and Payment of Fees  
2 and Costs of the Receiver and His Professionals for the Period from October 1, 2023 through  
3 December 31, 2023 (the “Tenth Application”) and the Court having heard oral argument on that  
4 application at a hearing on March 18, 2024, and with good cause appearing,

5 **IT IS ORDERED that:**

6 (1) Geoff Winkler (the “Receiver”) and American Fiduciary Services are allowed  
7 \$66,229.50 in fees and \$349.97 in costs;

8 (2) Greenberg Traurig is allowed \$14,725.02 in fees;

9 (3) Smiley Wang-Ekvall, LLP, is allowed \$10,578.36 in fees and \$90.99 in costs;

10 (4) Technology Concepts & Design, Inc. (“TCDI”) is allowed \$624.00 in fees and  
11 \$24,389.30 in costs;

12 (5) Baker Tilly is allowed \$250.00 in fees;

13 (6) The Receiver is authorized to pay 80% of the allowed fees and 100% of the  
14 allowed costs from funds on hand in the receivership estate:

- 15 a. \$52,983.60 of Receiver fees and \$349.97 in expenses;
- 16 b. \$11,780.02 of GT fees;
- 17 c. \$8,462.68 of Smiley Wang-Ekvall fees and \$90.99 in expenses;
- 18 d. \$499.20 of TCDI fees and \$24,389.30 in expenses;
- 19 e. \$200.00 of Baker Tilly fees.
