ADMINISTRATIVE ORDER NO. 001, SERIES OF 2025

AN ORDER IMPOSING NEW POLICIES ON NATIONAL AND REGIONAL FEES FOR NEW MEMBERS AND RENEWAL OF REGULAR MEMBERS OF THE FRATERNAL ORDER OF EAGLES – PHILIPPINE EAGLES AND ORDERING ITS NATIONAL IMPLEMENTATION.

WHEREAS, while we await for the conduct of a special National Assembly this month of January 2025, called to approve and authorize the adoption and implementation of a National Budget, there is a need to temporarily adjust and enforce uniform fees on renewal and new membership applications.

NOW, THEREFORE, I, EAGLE JASON M. MASA, National President for EY 2025-2026, by virtue of the powers vested in me by the Philippine Eagles Constitution of 2024, HEREBY ORDER, that:

- Short Title.** This Order shall be known and cited as the "Eagles Fees Adjustment Order of 2025;
- New Shares for the Club.** There shall now be shares provided for the Club in the amount of P500 from the new membership application fees, and P200 from the renewal
- Fees Adjustments.** Henceforth, the fees assessed for new and regular members, respectively, shall be as follows:

4. ***New Membership Fee and Regular Members’ Annual Renewal; How paid.*** Except for Regional Dues and ORIENTS Fee, which will be remitted respectively to Regional Treasurer and Orients-conducting PEIL Director/Rosei concerned, all the rest of the remaining fees for the National Office shall be remitted to the National Bank Account of the Philippine Eagles, **BY THE CLUB TREASURER ONLY**, with written notice to the National Treasurer, in a form of Transmittal Letter, specifying therein the Region, Club and Names of the paying members, clearly showing the total amount paid or transmitted. **THE NEW MEMBERS’ FEES AND NATIONAL RENEWAL DUES SHALL BE REMITTED BY THE CLUB TREASURER DIRECT TO THE NATIONAL, OR TO THE NATIONAL DEPOSITORY BANK ACCOUNT**, upon prior approval of the regional governor concerned for the authority to remit.
5. ***Unlawful Delay of the Remittance.*** The Club Treasurer shall deposit the fees no more than seven (7) calendar days from receipt of payment by the members or applicants, as evidenced by an acknowledgment receipt issued by the Club Treasurer to the paying member/applicant. Prior to the sending, the Club Treasurer, thru the Club President, shall inform the regional governor of the remittance and secure his approval to remit. After the approval, the Club Treasurer will coordinate with the National Treasurer.
6. ***Effectivity.*** This Order shall take effect immediately following its publication and circulation in the Official Communications Page in the social media, and official Notice to all Regions and Clubs under the jurisdiction of the Philippine Eagles.
