FINANCIAL UPDATE

From Doug Sweeder—Finance Chair

1. Finance made available money to cover our expected expenses though the first quarter and indeed our actual Income covered our actual Expenses during this period. Finance did this by using extra money from the endowment and other savings sources. We have about \$1,500 to start April.

Some members have stepped up and donated money above their pledge. All of us can say thank you to those members. It does make a difference.

Finance has **not** drawn down our reserves, which are limited, for the remaining months of 2022. We will monitor our financial status on a month-by-month basis.

2. The United Methodist Union approved our loan request for \$51,300. If we have a successful outcome in the lawsuit, we probably will not need to take the loan. Instead, we will be able to use the escrowed funds for remediation. Currently, the money in escrow is not available until the lawsuit is settled.

- 3. Roof Status
 - A. United Restoration, our roofing contractor, filed a lawsuit to make us pay the remainder of the insurance money. We haven't paid them because of the extensive damage they caused to the interior of the church. I think we all have a vivid memory of the extensive amounts of water leaking into the church over a five-month period.
 - B. We are counter-suing United Restoration for the difference between the money we put in escrow and our outside contractor's estimates of the damage done. The difference is sub-stantial
 - C. Marcus and I filed a claim for the money that Church Mutual will make available to us for legal expenses. It was approved by Church Mutual. Where lawsuits are concerned, this isn't a lot of money, but we are absolutely happy to have it. Hopefully, we will be able to keep our legal expenses within this amount.
 - D. Our roof team is working well together. Bud Warner was an excellent addition to the team about a year ago.
- 4. The Finance team is ready to support the Leadership team to resolve our membership and financial issues. We are open to any ideas for growth and outreach to the community. Put your thinking caps on and feel free to express your ideas. Also, read the Spire for upcoming event opportunities.
