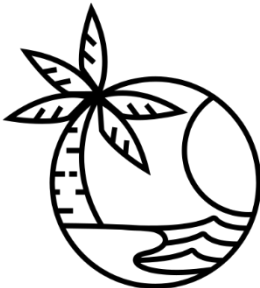

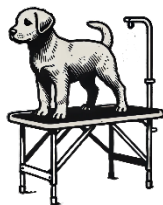

The Pee Wee Event is for children from the ages of 5 to under 9 years of age. Each Pee Wee class consists of the child and a responsible adult which must be in the ring with the Pee Wee. The dog must be at least 4 months of age and have the proper lead and collar. At an All-Breed event, all AKC fully recognized and Miscellaneous Class breeds are allowed to enter, including dogs with a PAL listing. In addition, FSS breeds and All-American dogs may be allowed at the discretion of the Club. The responsible adult is responsible for the control of the dog outside the ring. Clubs must provide an additional lead if the mentor inside the ring feels that it is necessary for the safety of the dog and the Pee Wee. A Release of Liability must be completed before the Pee Wee may enter the Pee Wee Event. For more information on the Pee Wee Event, please refer to the AKC website at:

Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in any NOHS competition during the entire show. **NOVICE INTERMEDIATE CLASS:** For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**NOVICE SENIOR CLASS:** For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN JUNIOR CLASS:** For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN INTERMEDIATE CLASS:** For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN SENIOR CLASS:** For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. Subsequent returned checks or declined cards from the same exhibitors may result in their being put on a **CASH ONLY** basis.

**CHARGEBACKS on Credit Cards** are considered a violation of your agreement to pay the required entry fee for entry into a show and the AKC Compliance Dept. will be notified for their disciplinary action. An AKC Recording Fee of \$3.50 will be required for each first entry and \$3.50 for each additional entry in any Licensed or Member Club Rally Trial. An AKC Event Service Fee of \$2.00 per entry will be required for each dog entered at any Open Show. All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions.)

**No Entry** shall be made, and no entry shall be accepted which specifies any conditions as to its acceptance.

**Entry Fees** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management, it is impossible to open or to complete the event, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. Claims for prize money must be made in the ring before the judging of that breed is over, and the Secretary advised at once. The Secretary and Show-Giving Club disclaim any liability for cash prizes after the judging of the breed is over.
