

PUPPY LOVE GROOMING AND BOARDING KENNEL

Owner Boarding Agreement

TERMS AND CONDITIONS Puppy Love LLC (Kennel) agrees to exercise due care and caution in the boarding of Domestic animals (pet). Premises will be kept clean and secure. Pet(s) will be fed properly and regularly, will be monitored and will be housed in separate, climate controlled quarters. Due diligence, care and caution having been exercised by Kennel, Pet Owner(Owner) agrees that all Pets are accepted for boarding, training, grooming or other care without liability for loss or damage from disease, death, running away, theft, fire, injury to persons, or other animals or property by said pet, fence climbing, or other unavoidable causes or other condition resulting from any cause. Except in the case of emergency, pet will not be removed from Kennel premises. It is expressly agreed by OWNER and KENNEL that KENNEL liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200.00 per pet boarded. The OWNER further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the Kennel.

Any Pet, while in possession of Kennel, which is found to have external parasites will be bathed and treated at OWNER'S expense. If Pet should become ill while in possession of Kennel or if the state of the Pet's health requires professional attention, Kennel will attempt to contact Owner. The Kennel, in its sole discretion, may engage the services of a veterinarian or administer medicine, or a special diet, or give other requisite attention including peanut butter, pumpkin, and other supplement's to the pet and the expenses thereof shall be paid by the OWNER. If OWNER cannot be expeditiously contacted and/or if no veterinarian is specified by OWNER, KENNEL will place PET in the care of Veterinarian of KENNEL'S choice. OWNER SHALL BE RESPONSIBLE FOR ALL NECESSARY HEALTH AND VETERINARY CARE AS MAY BE DETERMINED BY THE KENNEL.

In the rare and unfortunate event that the Pet dies in our care, your Pet will be taken to your designated veterinarian and maintained for pick-up or further instruction. If Owner cannot be expeditiously contacted and/or if no veterinarian is specified by OWNER, KENNEL will place PET in the care of Veterinarian of KENNEL'S choice.

The daily boarding charge applies the day pet is dropped off and each subsequent day the pet is kept after 12:00 noon.

OWNER may provide bedding or toys for pet. KENNEL may also provide a pillow, blanket, or other type bedding at KENNELS discretion. KENNEL is not responsible for any damage to beds or toys or medical problems resulting from pet's chewing on beds or toys.

NOTIFICATION: Should it become necessary to contact OWNER for any reason, KENNEL will attempt to telephone OWNER at the number listed below. If unable to contact OWNER, KENNEL will attempt to telephone "Alternate contact" below. Depending on circumstances, KENNEL is authorized to contract for care of PET with OWNERS Veterinarian, as listed below. If a Veterinarian is not indicated below by OWNER or cannot be reached, KENNEL may contract with KENNELS Veterinarian as may be considered necessary to protect the health of the Pet.

NON-PAYMENT OR ABANDONMENT: Should OWNER not retrieve PET with ten (10) days of scheduled date, or should OWNER not arrange for the full payment of all services at the time of pick-up, Pet shall be considered abandoned and may become property of the KENNEL. KENNEL shall have the right to sell PET to recover costs, OWNER shall be responsible for any shortfall of costs recovered; any excess shall be refunded by KENNEL to OWNER. Notice of such sale shall be mailed by KENNEL via US Certified Mail to OWNER'S address shown below. KENNEL shall attempt to provide ten (10) days notice of any such action. KENNEL WILL prosecute OWNERS for any abandonment of PETS according to local laws.
