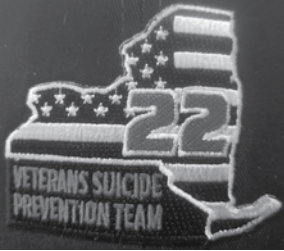

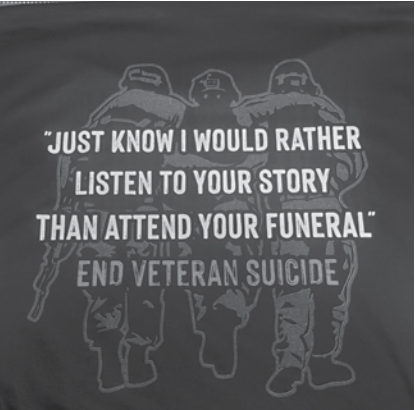

## How Can Military Veterans Maximize Their Tax Benefits? Expert explains federal and state tax breaks for retired service members

Updated February 15, 2022

En español | Filing taxes once you're retired from the military may seem less complicated than it was when you were still in the service, yet military veterans can still get important benefits from the tax code. You don't want to miss out on them.

To help with your 2021 tax filings, we spoke with CPA and tax expert Lisa Greene-Lewis of TurboTax, who provided helpful information specifically for military veterans. Remember to file your taxes before this year's April 18 deadline. And don't forget: Tax advice that applies to civilians can benefit you, too.

### Federal Taxes

**You'll owe federal income taxes on military retirement pay.** However, if you participate in the Survivors Benefit Plan, which supports your beneficiaries after you die, your premiums are excluded from your taxable income. Additionally, your military retirement pay is not considered earned income for Social Security tax calculations, and no Social Security payroll tax should be withheld from that pay.

**Veteran education benefit payments** received through the Department of Veterans Affairs (VA) for education and training are tax-free.

**Disability benefit payments** from the VA aren't taxable. This includes disability compensation and pension payments, disability grants for home or vehicle modifications (such as wheelchair ramps), and benefits under dependent-care assistance programs.

**Veterans and active military save up to 30% on AARP Membership.** Get instant access to discounts, programs, services, and the information you need to benefit every area of your life.

**Note:** If you recently had an increase in your disability rating or were granted Combat-Related Special Compensation, you may be eligible for a tax refund. However, this can be applied only to the year that the VA reassessed your disability level, and you may have to file an amended return.

Other money from the VA that is not taxed:

- Interest from VA life insurance policies
- Benefits under a dependent-care assistance program
- Money paid to a survivor of a member of the armed forces who died after Sept. 10, 2001
- Payments made under the compensated work therapy program
- Any bonus pay from a state, county, city or town because of service in a combat zone

**Missing money from stimulus checks** may still be obtained through the Internal Revenue Service's (IRS) Recovery Rebate Credit.

"The IRS used information from the [VA] to issue the stimulus payments," said Greene-Lewis.

So, if you received a partial payment based on the information they had in prior years, you may be eligible for more in the form of a recovery rebate credit when you file your 2021 taxes.

### State Taxes

#### Fast facts on state taxes:

- States typically offer tax benefits only to veterans who were honorably discharged or released from active duty under honorable circumstances.
- State benefits usually include exemptions on property taxes, according to value.
- Benefits are often transferred to a spouse or surviving spouse of honorably discharged veterans.
- Many states include additional benefits for veterans who are disabled.
- Every state's revenue website outlines state benefits for veterans and how to apply for them.

**Disabled veterans** can qualify for property tax exemptions at the state level. These breaks, which are usually tied to a specific disability rating, can help a veteran save thousands of dollars. You can view a list of all property tax exemptions by state and disability percentage here. However, since tax laws often change, it is best to verify the tax structure with your taxpayer assistance center, state tax office or tax professional.

Military retirement pay may be untaxed or have other special provisions in some states. Review a list of states that do and don't tax military retirement pay here. If you are eligible, verify the tax law with your local taxpayer assistance center, state tax office or tax professional.

### AARP Tax-Aide

AARP Foundation's Tax-Aide program, the largest free, volunteer-based tax assistance and preparation program in the U.S., provides in-person and virtual tax help.

The nationwide program is aimed at people 50 and older or those who have low to moderate incomes, but Tax-Aide is open to anyone, free of charge. You don't need to be an AARP member to take advantage of Tax-Aide's knowledgeable volunteers, nor will there be any sales pitch for other services. Tax assistance is available by appointment only.

A variety of other resources are also available to provide free tax prep help for eligible military families and older adults.

The NYS Council of Veteran Organizations consists of more than 30 veteran service organizations including the Veterans of Foreign Wars, Disabled American Veterans, AMVETS, Fleet Reserve Association, and Marine Corps League to mention a few.

The VFW New York Division is an active member of NYSCOVO and concurs with this testimony.

This budget year has started off in a very positive direction with the Governor mentioning in her message and budget presentation key programs that our organizations have also identified during the past several budget cycles as critical to sustainable veterans' services delivered in a unified and accountable fashion. The following are our budget priorities.

You can choose either the Moderna or Pfizer-BioNTech COVID-19 vaccine for your second booster.

### Stay up to date on your COVID-19 vaccines

Staying up to date on your COVID-19 vaccines is the best way to protect yourself and your family. Vaccines and boosters continue to protect against new forms of the coronavirus (like Omicron). If you're eligible, come in for your COVID-19 booster, second booster, or additional dose now.

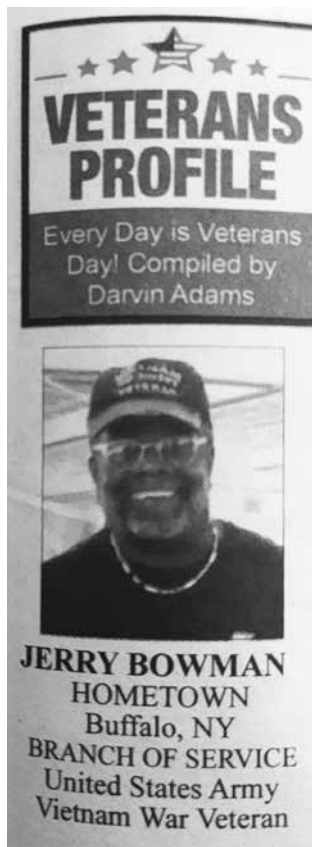

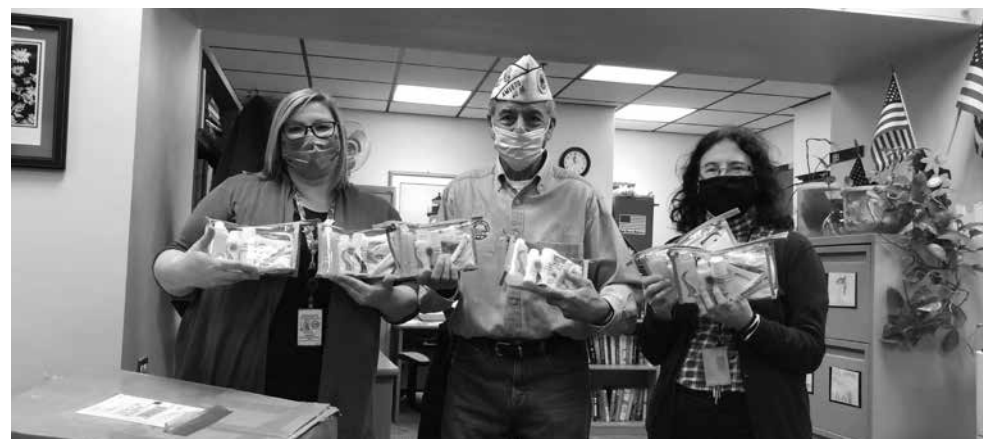

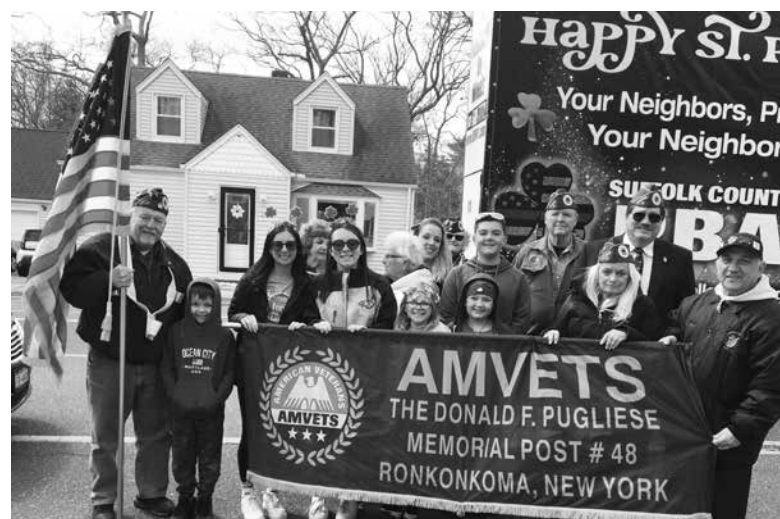

Amvets 282 Potsdam Mourn Loss of Three WWII Member Veterans

Recently, Amvets 282 lost a trio of WWII fame!



We were honored to have known and loved these guys along with the tales they had to tell. With a twinkle in the eye and a chuckle, these heroes were a delight to be around. It was an honor to have called them “friend”. They have left our sight, but live on in our hearts and memories.

Charles Alexander, 96 (8 Dec 1924—25 Nov 2021)

At age 17 Charlie enlisted in the US Navy serving a three-year term that included the Normandy invasion on an LST-208 boat—making 14 landings on Omaha, Utah and Sword Beaches. He moved on to the Pacific theater serving in Guam, Saipan, Tinian, and the Okinawa invasion. Memories of his war experiences were recounted with humility and thanks to God that he was spared to return to his beloved Canton NY to serve his community, his church, and his family for many years to follow. Charlie was the “real deal”. Those of us who were lucky enough to know and love Charlie Alexander, are truly blessed.



Lloyd B Brown, 98 (June 6, 1923–Feb 4, 2022)

Lloyd enlisted in the Army as a young lad and found himself on the beaches of Normandy on D-Day of 1944, his 21st birthday. He survived the invasion and served in Normandy, Rhineland, No. France as a corporal cannoneer. He received a purple heart during his service in the Atlantic Theater. His memories of the War remained quite vivid even as his hearing and eyesight faded in later years.



Lloyd continued serving his community as a special sheriff’s deputy, playing his guitar in various bands around the North Country, and enjoying trading and bartering lots of “Stuff” at his home on the Douglas Road in the Town of Potsdam where his life had begun some 90 years plus years ago. If you heard Lloyd say, “I’ll tell you what I had to pay for that”... look out, because that’s when the stories started, and you knew you would not come out on the good side of that deal!

James P Autenrith, 97 (1 Oct 1923--20 Sept 2021)

James served in WWII as a Chaplain’s assistant. His talents were so well thought of that he was asked to play the organ for the funeral of General George Patton in Mannheim, Germany. Later, James taught organ for over 46 years at Michigan State and at the Crane School of Music in Potsdam NY. James also gave of his organ playing talent to the Methodist Church in Potsdam for many, many years.
