Canyon Park Property Owners Association 'Helping Hands' Collection Policy

The Canyon Park Property Owners Association (CPPOA) provides essential services to the Canyon Park community and is authorized by its deed restrictions 'Subdivision Restrictions and Reservations for Canyon Park, A Rural Subdivision', to provide the community an avenue for residents to be able to hold personal yard, garage, rummage, moving, estate, craft, etc. sales. The Canyon Park POA holds such sales in the last week-end of April and the last week-end of September of each calendar year.

In addition, the deed restrictions 'Subdivision Restrictions and Reservations for Canyon Park, A Rural Subdivision' allow for any resident, including rental properties, to hold these type of personal sales at any time of the year at the expense of \$10.00 per day and with the approval of the CPPOA.

One hundred percent (100%) of these funds will go into an account known as the "Helping Hands Account", which will provide funds to the Subdivision property owners in need of assistance to be used for clean-up, general maintenance, or repairs.

Residents wishing to have such sale should make a written request to CPPOA office and:

- 1. Be current on all maintenance fees
- 2. Sales cannot be more than 3 consecutive days in a row and no more than 6 times per calendar year.
- 3. All items must be removed from view upon completion of the sale.
- 4. Payment is due upon approval and before any sale can occur.

People requiring assistance should make a written request to CPPOA office detailing:

- 1. Task to be performed
- 2. Name and address
- Number of people residing in the home
- 4. The issue to be solved
- 5. The deed restriction violation that may apply
- Hazards that may or has occurred
- 7. Age
- 8. Financial status or hardship.

The CPPOA Board Members will make decisions on the request as it is received. Decisions shall be based on the details provided, number of applicants, dollar amount in the fund, and the dollar amount cost of the project. CPPOA Board members may approve several applicants per calendar year, but are to never exceed the amount in the fund.

This Policy is effective upon filing with the County Clerk office of Polk County, Texas.
