Assumption of Risk

I understand that surf fishing is an outdoor recreational activity that involves risks, hazards, and dangers, both known and unknown. These risks may result in injury, illness, property damage, or death.

I understand that risks associated with guided surf fishing may include, but are not limited to: hooks, knives, fishing tools, fish spines, stingrays, sharks, jellyfish, bait handling, allergic reactions, sunburn, dehydration, heat exhaustion, waves, currents, lightning, changing weather, equipment failure, slipping or falling on sand or wet surfaces, drowning, and other natural beach or ocean hazards.

I understand that Panhandle Salt does not control the weather, surf conditions, marine life, fish behavior, or other natural conditions.

By signing this form, I voluntarily choose to participate and I knowingly assume the risks associated with this activity.

Release of Liability

In consideration of being allowed to participate in a guided surf fishing trip with PerdidoBlane LLC d/b/a Panhandle Salt, I agree to release, waive, discharge, and hold harmless PerdidoBlane LLC d/b/a Panhandle Salt, its owners, guides, employees, agents, contractors, representatives, and affiliates

from any and all claims, demands, actions, losses, damages, injuries, costs, or expenses arising out of or related to my participation in the guided fishing activity.

This release includes claims related to ordinary negligence, to the fullest extent allowed by Florida law. This release does not apply to claims that cannot legally be waived under Florida law, including gross negligence, intentional misconduct, or other conduct that Florida law does not allow to be released in advance.

No Guaranteed Catch

I understand and agree that fishing results are never guaranteed. Panhandle Salt does not guarantee that I will catch fish, catch a certain species, catch a certain size of fish, or experience specific weather, surf, or fishing conditions.

Weather, Safety, Rescheduling, and Refunds

I understand that outdoor fishing trips are subject to weather and safety conditions.

If Panhandle Salt determines that weather, lightning, surf, or other conditions make the trip unsafe or unsuitable, the trip may be rescheduled or refunded. The final decision regarding weather and safety is made by Panhandle Salt and/or the guide.

Participant Responsibilities

I agree to follow all safety instructions given by the guide.

I agree to handle all fishing equipment, hooks, bait, fish, and tools carefully.

I agree not to enter the water unless instructed that it is safe to do so.

I agree to dress appropriately for outdoor beach conditions, including sun exposure, heat, sand, wind, and changing weather.

I agree to bring or use appropriate sun protection, water, and any personal medical items I may need.

I confirm that I am physically able to participate in beach surf fishing, including standing, walking on sand, being outdoors in sun and heat, and being near ocean water.

Alcohol and Drugs

I agree that I will not participate while under the influence of alcohol, illegal drugs, or any substance that could impair my judgment, coordination, or ability to safely participate.

Panhandle Salt may refuse participation if a participant appears impaired or unsafe to participate.

Medical Authorization

In the event of an injury, illness, or emergency, I authorize Panhandle Salt and/or its guide to seek emergency medical assistance on my behalf, including calling 911, EMS, or other emergency services.

I understand that I am responsible for any medical costs related to my care.

Transportation

I understand that Panhandle Salt does not provide transportation.

Participants are responsible for arriving at the designated meeting location and leaving the location after the trip.
