The Twitter Files

Since his purchase of Twitter, Elon Musk has directed many changes to include dismissing the "C-level" executives along with about 50% of the employees. In addition to the massive personnel changes, Musk has provided journalists Matt Taibbi, Bari Weiss, Lee Fang, and authors Michael Shellenberger and David Zweig with access to internal Twitter, Inc. documents such as screenshots, emails, and chat logs for them to analyze and present to the public via a series of "Twitter File" releases on Twitter. As of this writing, there have been 10 threads, known as "Parts", released. Each Part covers a different topic. I'll give you an idea of what these are about and links to each:

Part 1 by Matt Taibbi @mtaibbi consists of 33 tweets. The first 7 are as follows: What you're about to read is the first installment in a series, based upon thousands of internal documents obtained by sources at Twitter. The "Twitter Files" tell an incredible story from inside one of the world's largest and most influential social media platforms. It is a Frankensteinian tale of a human-built mechanism grown out the control of its designer. Twitter in its conception was a brilliant tool for enabling instant mass communication, making a true real-time global conversation possible for the first time. In an early conception, Twitter more than lived up to its mission statement, giving people "the power to create and share ideas and information instantly, without barriers." As time progressed, however, the company was slowly forced to add those barriers. Some of the first tools for controlling speech were designed to combat the likes of spam and financial fraudsters. Slowly, over time, Twitter staff and executives began to find more and more uses for these tools. Outsiders began petitioning the company to manipulate speech as well: first a little, then more often, then constantly. By 2020, requests from connected actors to delete tweets were routine. One executive would write to another: "More to review from the Biden team." The reply would come back: "Handled."

follows: A new #TwitterFiles investigation reveals that teams of Twitter employees build blacklists, prevent disfavored tweets from trending, and actively limit the visibility of entire accounts or even trending topics—all in secret, without informing users. Twitter once had a mission "to give everyone the power to create and share ideas and information instantly, without barriers." Along the way, barriers nevertheless were erected. Take, for example, Stanford's Dr. Jay Bhattacharya (@DrJBhattacharya) who argued that Covid lockdowns would harm children. Twitter secretly placed him on a "Trends Blacklist," which prevented his tweets from trending.

For years, Twitter had resisted calls both internal and external to ban Trump on the grounds that blocking a world leader from the platform or removing their controversial tweets would hide important information that people should be able to see and debate. "Our mission is to provide a forum that enables people to be informed and to engage their leaders directly," the company wrote in 2019. Twitter's aim was to "protect the public's right to hear from their leaders and to hold them to account." But after January 6, as @mtaibbi and @shellenbergermd have documented, pressure grew, both inside and outside of Twitter, to ban Trump. There were dissenters inside Twitter. "Maybe because I am from China," said one employee on January 7, "I deeply understand how censorship can destroy the public conversation." SUBSIDIARY The #TwitterFiles are revealing more every day about how the government collects, analyzes, and flags your social media content. Twitter's contact with the FBI was constant and pervasive, as if it were a subsidiary. Between January 2020 and November 2022, there were over 150 emails between the FBI and former Twitter Trust and Safety chief Yoel Roth. Some are mundane, like San Francisco agent Elvis Chan wishing Roth a Happy New Year along with a reminder to attend "our quarterly call next week." Others are requests for information into Twitter users related to active investigations. But a surprisingly high number are requests by the FBI for Twitter to take action on election misinformation, even involving joke tweets from low-follower accounts. The FBI's social media-focused task force, known as FTIF, created in the wake of the 2016 election, swelled to 80 agents and corresponded with Twitter to identify alleged foreign influence and election tampering of all kinds. Federal intelligence and law enforcement reach into Twitter included the Department of Homeland Security, which partnered with security contractors and think tanks to pressure Twitter to moderate content. It's no secret the government analyzes bulk data for all sorts of purposes, everything from tracking terror suspects to

making economic forecasts. The #TwitterFiles show something new: agencies

like the FBI and DHS regularly sending social media content to Twitter through

multiple entry points, pre-flagged for moderation.

In Twitter Files #7, we present evidence pointing to an organized effort by representatives of the intelligence community (IC), aimed at senior executives at news and social media companies, to discredit leaked information about Hunter Biden before and after it was published. The story begins in December 2019 when a Delaware computer store owner named John Paul (J.P.) Mac Isaac contacts the FBI about a laptop that Hunter Biden had left with him On Dec 9, 2019, the FBI issues a subpoena for, and takes, Hunter Biden's laptop. By Aug 2020, Mac Isaac still had not heard back from the FBI, even though he had discovered evidence of criminal activity. And so he emails Rudy Giuliani, who was under FBI surveillance at the time. In early Oct, Giuliani gives it to @nypost Shortly before 7 pm ET on October 13, Hunter Biden's lawyer, George Mesires, emails JP Mac Isaac. Hunter and Mesires had just learned from the New York Post that its story about the laptop would be published the next day. At 9:22 pm ET (6:22 PT), FBI Special Agent Elvis Chan sends 10 documents to Twitter's then-Head of Site Integrity, Yoel Roth, through Teleporter, a one-way communications channel

The first 2 are partially excerpted as follows: TWITTER FILES PART 8 *How Twitter Quietly Aided the Pentagon's Covert Online PsyOp Campaign* Despite promises to shut down covert state-run propaganda networks, Twitter docs show that the social media giant directly assisted the U.S. military's influence operations. Twitter has claimed for years that they make concerted efforts to detect & thwart govbacked platform manipulation.

The first 6 are as follows: THREAD: The Twitter Files TWITTER AND "OTHER GOVERNMENT AGENCIES" After weeks of "Twitter Files" reports detailing close coordination between the FBI and Twitter in moderating social media content, the Bureau issued a statement Wednesday. It didn't refute allegations. Instead, it decried "conspiracy theorists" publishing "misinformation," whose "sole aim" is to "discredit the agency." They must think us unambitious, if our "sole aim" is to discredit the FBI. After all, a whole range of government agencies discredit themselves in the #TwitterFiles. Why stop with one? The files show the FBI acting as doorman to a vast program of social media surveillance and censorship, encompassing agencies across the federal government – from the State Department to the Pentagon to the CIA. The operation is far bigger than the reported 80 members of the Foreign Influence Task Force (FITF), which also facilitates requests from a wide array of smaller actors - from local cops to media to state governments. Twitter had so much contact with so many agencies that executives lost track. Is today the DOD, and tomorrow the FBI? Is it the weekly call, or the monthly meeting? It was dizzying.

partially excerpted as follows: THREAD: THE TWITTER FILES: HOW TWITTER RIGGED THE COVID DEBATE – By censoring info that was true but inconvenient to U.S. govt. policy – By discrediting doctors and other experts who disagreed – By suppressing ordinary users, including some sharing the CDC's *own data* So far the Twitter Files have focused on evidence of Twitter's secret blacklists; how the company functioned as a kind of subsidiary of the FBI; and how execs rewrote the platform's rules to accommodate their own political desires. What we have yet to cover is Covid. This reporting, for The Free Press, @thefp, is one piece of that important story. The United States government pressured Twitter and other social media platforms to elevate certain content and suppress other content about Covid-19. Internal files at Twitter that I viewed while on assignment for @thefp showed that both the Trump and Biden administrations directly pressed Twitter executives to moderate the platform's pandemic content according to their wishes. At the onset of the pandemic, according to meeting notes, the Trump admin was especially concerned about panic buying. They came looking for "help from the tech companies to combat misinformation" about "runs on grocery stores." But . . . there were runs on grocery stores. It wasn't just Twitter. The meetings with the Trump White House were also attended by Google, Facebook, Microsoft and others. When the Biden admin took over, one of their first meeting requests with Twitter executives was on Covid. The focus was on "anti-vaxxer accounts." Part 10 can be found by CLICKING HERE


