**Item 1:** CALL TO ORDER

### **Item 4:** REPORT FROM ROAD COMMITTEE

Mary Harmon expressed concern over the condition of the bridge near the fish ladder. Other members share the same concern. David Cole offered to work directly with those who built the bridge over the Canoe River and to pursue possible sources of funding from the state.

**Warrant Item B:** To share the findings of a legal review of the formation and ongoing structure of BRMA.

Patty shared the results of a review by an attorney of the BRMA formation, structure and bylaws. Deke Talbot had previously provided legal support for BRMA until he retired in 2019. An attorney from Murray, Plumb & Murray of Portland was selected based on a reference and the firm's strong reputation. Sage Friedman performed the review in March 2020. The conclusions were provided in a letter that was shared with the members at the meeting. The summary of the findings:

The BRMA was formed in accordance with the requirements of 23 M.R.S. § 3101, and the BRMA is authorized under Maine law to provide road maintenance over private ways and to levy annual road fees against properties that benefit from the use of such private ways.

#### **Item 6**: NEW BUSINESS

Chris O'Connell complimented the members for their cordial approach to the association business and expressed his support for the collaboration and fiscal responsibility displayed. He explained that his gate and lock at Pleasant River Lake Properties Lot 36 had recently been tampered with and asked if other members' properties had been damaged. Leanne Jandreau at Southwest Bluff Lot 12 explained that tools had recently been taken from her shed. No other members reported any issues.

**Item 7:** Per Article III, Sections 4 & 5 of the By-laws, following debate as desired, vote on the amount and structure of the annual road maintenance charge. The members unanimously voted to continue with \$150 per year for road fees.

Juan asked those in attendance if virtual meeting in mid-summer for the Annual Meeting is the best option for 2021. Those in attendance approved a virtual meeting for 2021 using Zoom as the preferred platform. The meeting will be scheduled on a weeknight in mid-summer — actual date and time will be sent with the meeting warrant in Spring 2021.

The meeting adjourned at approximately 8:15 pm.
