### FINANCIAL REPORT Fiscal Officer Cheryl Welch

- Receipts between 12/14/2021 and 1/10/2022 totaled \$19,358.85 Expenses totaled \$10,802.78. Fund balances totaled \$332,992.55 (Primary account is \$141,973.16)
- \$191,019.39 or 57% of the fund balance is money from ARPA.

#### PUBLIC PARTICIPATION

- Candidate Victor Perez for Ashland County Court of Common Pleas introduced himself and gave us
  insight into the many court rooms he has worked in from Cleveland to Lorain to Ashland prosecuting
  criminal cases in front of dozens of judges. Perez is currently a prosecutor in the Ashland County
  Prosecutors Office.
  - ✓ Mr. Perez started his legal career as an Assistant Director of Law for the City of Cleveland in the Department for Consumer Affairs in 2002.
  - ✓ In 2003, Mr. Perez became an Assistant Prosecutor for the City of Cleveland where he prosecuted thousands of misdemeanor cases.
  - ✓ In 2006, Mr. Perez was appointed as the Chief Prosecutor for the City of Cleveland and served in that capacity until 2015, becoming the longest serving City Prosecutor. In his capacity as Chief Prosecutor, Mr. Perez oversaw the daily operations of the Prosecutor's Office as well as prosecuting cases.
  - ✓ In 2015, Mr. Perez joined the Lorain County Prosecutor's Office where he prosecuted felony level offenses.
  - ✓ Mr. Perez joined the Ashland County Prosecutor's Office in December 2016.
- Concerned resident Scott Cantrell gave his insight into situation regarding resident that might be running a trucking business out of his home on 53.
