# Jackson Township-Ashland County, Ohio 799 Co. Rd. 175 West Salem, Ohio 44287

July 8, 2019

Regular Meeting called to order by Trustee Chairperson Scott Markley with the Pledge of Allegiance. Present Trustees Scott Markley, Kay Wright and Jim Power, Zoning Inspector Steve Nemec, Road Supervisor Herb Wiles absent. Guests present Kenny Howell, Victor Dubina, Walter Miller, Ronda Dreibelbis, Allen Blodget, Chris Galazka, Gidean Swartzentruber and John Taranowski . Fiscal Officer Cheryl Welch absent from this meeting, Trustee Kay prepared minutes for this meeting.

Minutes for the June 24<sup>th</sup> meeting were not read or approved.

#### Road Report

Trustee Scott reported on culvert replacement on Twp.Rd.1080; job is done culvert and water basin renewed. Road is open, but road closed sign was taken. 35ft. of guard rail is needed for area—Trustees Katie and Jim are to get pricing.

#### Zoning:

Zoning Inspector Steve addressed Gidean Swartzentruber's question about signage, sign must be 10ft.off of road rt. away and not on an electric or telephone pole. But, no signage regulation was found in our Zoning Resolution.

Steve reported all cleanup is done on Twp.Rd. 133 and matter is resolved. Residents on Twp. Rd. 101 are starting to comply, baled front yard and have moved equipment back.

Trustee Jim felt a time stamp is needed for doing a complaint, job or request. After some discussion, Zoning Inspector Steve and Trustee Jim came to an agreement. Any complaint, job or request must be done in a timely matter of about 2 weeks because of Steve's job and family obligations.

Park Board:

Appeals Board member Kenney Howell reported to Trustee Jim that the trash bins are full and running over. Trustee Jim stated he will handle.

Trustee Jim reported to wet to do much work at the park.

#### Old Business:

Trustee Kay reported on purchase of small road roller from Cinnamon Lake Association for the price of \$1,200.00 A roll call vote of Trustees to accept agreement with purchase was taken: Chairperson Scott—YES Vice-Chairperson Jim—Yes Trustee Kay—Yes. Agreement signed and will be delivered by trustee Kay. Copy of Agreement attached.

Trustee Jim reported on signs needed for roads: Barricades \$90.00 to \$130.00, Road Closed w/lighting \$125.00, 6ft.wide w/triangle legs \$90.00, aluminum 6ft.stand w/floor boards \$130.00 to \$150.00 depending on sign size. After some discussion; Chairperson Scott recommended Trustee Jim get input from Road Supervisor Herb about how many signs to order and order them.

Trustee Kay reported Fiscal Officer Cheryl is working on the new Ohio Cemetery Grant.

Chairperson Scott introduced and welcomed 2 new Zoning Board members: Walter Miller and Victor Dubina.

### Cemetery Board:

Trustee Kay reported Herb has worked on straightening some stones. She; also, reported it has been very wet and spraying could not be done.

## Resident Comments and Concerns:

Chris Galazka stated large pot hole on Twp. . Rd. 251 just down from her home is getting larger and this is the second time she has reported it.

Allen Blodget stated we should make culvert pipes longer and plant grass on rails. He stated Herb does not know where right of way is and wastes time.. Allen, also, stated he would be willing to donate good sod to cemetery.

Trustee Jim, in answer to Allen, stated we used a private company to repair the deteriorating 1970 culvert on Twp.Rd.1080 and we had Herb oversee the project, but he did not stay there all day. We have, also, used the county for some of the jobs you mentioned, and I know you have used their work as an example. Herb cuts brush and trees when and if it safe for him to do so , but we have had private tree trimming companies do some to this work for us. Road

safety is one of our most important concerns. He thanked Allen for the donation of sod to the cemetery.

Trustee Scott asks if any questions on warrants or financial reports, as there were none, Trustee Jim made a motion to accept the warrants and financial reports, Trustee Kay seconded and Trustee Scott in agreement. The previously prepared checks were signed and placed in box as requested.

With no further business before the board the meeting was adjourned at 8:00 pm with a motion from Jim, Kay 2<sup>nd</sup> and Scott in agreement.
