CEMETERY Trustee Kay Wright

- Discussion took place on how to rectify water drainage problem. Idea that is in review: trench along each driveway and run field tile to drain towards the south; driveway high spots will be cut down.
- Kay is mailing a cemetery price sheet to all cometeries in and around the county.
- Kay made motion to take flag down for the winter and put a new one up in spring; Jim 2nd: Scott in agreement.

OLD BUSINESS

- Board made decision to stop doing any more patching this year due to change in weather. To date township has spent 3x as much on patching as they did in 2017. \$9,500 in (2017) and \$30,000 in 2018.
- Ed Meixner (County Engineer) has sold and delivered to the township 25 ton of salt at \$60/ton. Jim informed Cheryl township will be receiving a \$1,500 bill.

NEW BUSINESS

• Kay made motion to allocate \$4,000 for Tree Tender to cut trees and branches that Herb cannot cut himself; Jim 2nd; Scott in agreement.

Old Maynard Gas Station Clean-up Grant Project Update

- Drilling for the former <u>Underground Storage</u> Tank cavity and dispensers out in front of the building is underway. This round of drilling is to collect samples to evaluate potential impact from a septic leach field and a former hydraulic lift since service bays were present. Ohio EPA requested these two areas be investigated when they reviewed the grant application.
- Once that drilling event is completed, the drums will be scheduled for removal.
