#### FINANCIAL REPORT [Fiscal Officer Cheryl Welch]

- Receipts between 9/13/2022 and 10/10/2022 totaled \$16,415.04 Expenses totaled \$10,509.87. Fund balances totaled \$427,193.55 (Primary account is \$137,661.61)
- \$289,531.94 or 68% of the fund balance is money from ARPA.

#### OLD BUSINESS

- Update to request for No Brake sign on corner of 302 and 42. Board members signed a resolution for moving forward with ODOT to review. ODOT will do a site study, advise on sign specifications and sign placements.
- Law enforcement, as of 10/10/2022, will begin ticketing violators of the law that makes flashing yellow lights mandatory on Amish buggies, and other horse-drawn vehicles across the state. Residents who might observe violations of this law should call the Ashland County Sheriff's Office.

#### NEW BUSINESS

- Board has presented Ashland County Prosecutor Michael Donatini with paperwork regarding zoning certificate violations of Carl Way in May. Board made resolution #2022-6 to move forward with legal proceedings against Carl Way. Roll call vote: Scott (Yes), Jim (Yes), Kay (Yes). Residents, who attended the meeting, filled out complaint forms that will be forwarded to the prosecutor.
- Trebel electrical aggregate representative presented paperwork asking the board to authorize them as aggregators for the entire township. Board agreed and authorized Scott as signer.
- Jim presented information on an LED, Multicolor, Programable, Scrolling 69x36 informational sign. Board discussed and asked that Jim get a complete price together for sign and installation.




PUBLIC PARTICIPATION
