# FINANCIAL REPORT Fiscal Officer Cheryl Welch

- Receipts between 9/14/2021 and 10/11/2021 totaled \$12.32 Expenses totaled \$39,415.06. Fund balances totaled \$323,138.01 (Primary account is \$132,158.07)
- \$190,979.94 or 59% of the fund balance is money from ARP.
- Jim made motion to accept the financial report; Kay 2<sup>nd</sup> Scott in agreement.
- Leiby Construction was hired at a cost of \$1,031.25 to transport new mowing tractor from Piqua to our township house.

### **NEW BUSINESS**

- Jim made motion that Dave and James should gather up all the scrap around the township yard and take it to scrap yard, check to see if the old tires can be recycled, stumps burned, Kay 2<sup>nd</sup>, Scott in agreement.
- Scott has asked Spectrum consider expanding internet and cable service throughout the township since they do service Cinnamon Lake and the area surrounding us. He has had two meetings with them and they are undergoing a feasibility study right now.
