### ROAD REPORT Herb Wiles

- 5 miles of chip and seal done.
- Cistern and drain work completed for the restroom at a cost of \$1,665.
- Discussion regarding culvert on 101 by RR. Resident Mark McGraw reported no water was seen in the culvert; so his thinking is that the culvert pipe has collapsed again. Until replacement can take place Kay requested that Herb try to keep it clean.
- Accepted a resignation from Jimmy Hall. Trustee Power requested that Jimmy come to the township house to return the phone. Trustees have no problem with Jimmy keeping the number.

## ZONING REPORT Steve Nemec

- 312 Twp Rd 1080 barn going up was not permitted.
- 446 Route 42 structure is empty and owners have not responded to Steve's communication attempts.
- 373 Twp Rd 1080 junk vehicles are all operational and have current plates. Fence has been raised up as per Steve's orders.
- Brief discussion took place regarding the possibility of township zoning not overseeing building activity in Cinnamon Lake due to conflicts in the current resolution. For instance building requirements are 2 acres in the township; ½ acre in Cinnamon Lake.
- Resident Ross Oehling reported at 107 Twp Rd 604 occupied mobile home in the back yard. Kay thought Steve had checked on it once before and reported it was a playhouse for their kids. Discussion took place and it was determined that it is now being lived in.
- Resident Ross Oehling reported on Twp Rd 53 (House # unknown: Description was going north on 53 left side of road). Steve requested that resident Oehling get him the address. Many semi's.
- Resident Elaine Tanner (Tanner) wanted an update on semi's coming and going from Leiby property. Kay announced that the Appeals Board should have heard Elaine's concerns when initially brought forward. Kay said that the board of trustees were amiss in the handling of the business that Leiby's might be running on Twp Rd 251 as reported by Tanner. Tanner then read from a document that outlined the facts that she had accumulated on the Leiby case. Tanner demanded that the trustees put a stop to the activity that is taking place at the Leiby property which she is convinced is a construction business. Kristen Leiby was very forthcoming in saying she will provide any documentation the township requires to bring closure to this matter by proving business from farming is 51%.
- Resident Walt Miller wanted to know what the hash marks on the zoning map meant. Kay said planned unit development; so Miller than asked for documentation as to what this actually means. He was referred to the County Prosecutor.
