- · \$95,000 or 32% of the fund balance is money from ARPA earmarked for Spectrum internet project.

- Kay made RESOLUTION #2025-4 accepting the amounts and rates as determined by the budget commission and authorizing the necessary tax levies for the 2026 proposed budget. Jim 2nd; Scott in agreement.
