#### NEW BUSINESS

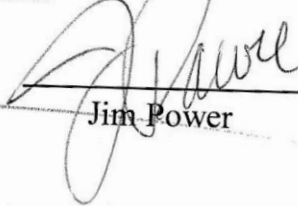
- Board will ask Clips & Cuts to submit bid for cemetery, park and twp house mowing & weed trimming.

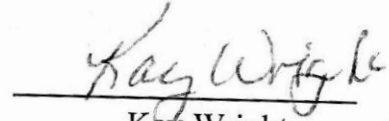
