GENERAL INFORMATION:

The election for Treasurer and Secretary will be held using an electronic tool, Election Buddy, via email. Voting will begin on June 14th and will close on June 30th. We are still looking for volunteers to fill these two offices, Secretary and Treasurer, for two years.

Greg McKeever will be the point of contact for the Firewise Program. Gene Constant reported that the USPS mail carrier (Shawn) can deliver mail up to 1/2 mile from the mailboxes.

DECISIONS:

The Board unanimously decided to purchase liability insurance for the HOA property and Board members. A carrier is still under consideration. American Family Insurance has provided a quote for \$859.

- Action Item: Mike Armstrong to research CPA rates. Due Date: 5/14/21.

The Board unanimously determined that only one person at a time should have the ability to load content on the FRE HOA website. For now, it will be Mike Armstrong.

• <u>Action Item</u>: **Alice Swanson** to research password protected information such as email lists and inventory on the website. <u>Due Date</u>: Completed.

Test of this capability was successful.

The Board unanimously decided to purchase an annual license for Election Buddy.

Mike Armstrong will administer Election Buddy for the upcoming election of Secretary and Treasurer.
