Barking dogs have become an issue again. The best way to resolve this issue is to speak with the dog-owner in a respectful manner. If the problem persists, lot owners should contact the Deschutes County Sheriff's Office at their non-emergency number: (541) 388-6655 or after hours: (541) 693-6911.

Reminder: Your dog must be on a leash in Fall River Estates if they are not on your property. This is a Fall River Estates CC&R rule.

**Speeding:** The speed limit in Fall River Estates is 25 miles per hour. There are reports of some residents consistently exceeding the speed limit, so this is a reminder that there are speed restrictions in our neighborhood. Violators can be reported to the Deschutes County Sheriff's Office. Having a video of the offender

is the best way to assist the Sheriff's Office. The Board might also request a radar speed trailer to remind drivers that they are exceeding the limit.

**Missing tool:** A breaker bar with a socket fell off John Spark's tractor. We want to keep John happy since he is our main snow removal guy so if you find it, let a board member know or return it to John Sparks.
