# 8/6/2021 FRE HOA Working Board Meeting Minutes- FINAL

#### **GENERAL INFORMATION:**

Fall River Estates is once again a Firewise community. Thanks Greg McKeever and the Firewise Team (Aileen Winge, Bill Swanson, John Burns, Tina Ward, and Beth McKeever)!

#### **DECISIONS:**

The FRE HOA board reversed course and voted to collect the \$100 annual HOA dues this year by a 4 to 1 vote. The reason for this change is related to a heightened awareness concerning the need to spend additional funds for increased fire mitigation. Also, the new bylaw changes requiring budget and large expenditure approval by the HOA community provide safeguards against unnecessary spending just because there is money available.

The results of the FRE HOA June election are as follows:

- Don Work and Kay Korzun elected to Director at Large and Secretary respectively. Their terms end June 2023.
- HOA annual budget now needs community approval
- Each year the FRE HOA board will review the need to collect annual dues
- Two signatures will now be required on each HOA check
- One of the two signature on an HOA reimbursement check cannot be the reimbursed individual
- A 15K contribution to the FRE SRD was approved
- Any expenditure over \$1,000 not in the annual budget will need community approval.

#### **ISSUES:**

There is a need for a **comprehensive Fall River Estates strategy and action plan for fire mitigation** created in cooperation with the FRE HOA, the Firewise Committee, the SRD, and various government agencies.

Items discussed related to this issue centered around the following topics:

- Need for multiple viable escape routes and safe spaces
- Improved insurability for homeowners
- Maintenance of a 100 ft buffer between FRE and government-owned land
- Homeowner education on assessment, fire mitigation, and availability of grants
- Possible inclusion in an environmental assessment already in progress to prevent delays in implementation
  - o Action Item: Mike Armstrong to reach out to block grant

coordinator for inclusion on environmental assessment. <u>Due Date</u>: 8/13/21 left message again on 8/9/21

- Community efforts to assist lot owners with fire mitigation activities
- Research into available grants
- Coordination with multiple government agencies at the County, State and Federal level
- Development of alternate fire suppression

To develop a fire mitigation strategy and plan, at least two meetings will be organized: the first with all FRE lot owners and then a second with the appropriate government officials and FRE lot owners.
