**Option One:** Just \$21.00 per person for the entire trip!

Benefits per person are:

- Primary medical coverage - \$50K per person!
- Medical evacuation - \$250K per person!
- Trip delay - if more than six hours, up to max \$750 (\$150/day).
- Missed connection – if more than three hours - \$500.
- Baggage Delay – must be more than 24 hours before you can make purchases.

**(Trip cancellation and full trip interruption benefits are not included).**

**Option Two:** Includes all benefits listed above plus 100% return for your trip cost if you are forced to cancel unexpectedly before your trip departure or up to 150% for trip interruption, while you are traveling, due to standard reasons such as illness, injury to you or to your traveling companion or illness/injury, death to an immediate family member. Or if you have to cancel due to work-related reasons.

Premiums are:

If your trip cost is between \$1001- \$1500 per person, premium is \$93 per person.

If your trip cost is between \$1501- \$2000 per person, premium is \$115 per person.

**Option Three:** For those who may want the Cancel for Any Reason upgrade, which means you can cancel for non-standard reasons, **you must purchase that plan within 14 days of putting down your first trip deposit! After that, the Cancel for any Reason plan will not be available.** Keep in mind that if you have to use the Cancel for Any Reason benefit, you will only be reimbursed 75% of your trip cost. If you cancel for standard reasons, and you purchased the Cancel for Any Reason upgrade, you will be reimbursed 100%.

Premiums are:

If your trip cost is between \$1001- \$1500 per person, premium is \$139.50 per person.

If your trip cost is between \$1501- \$2000 per person, premium is \$172.50 per person.

**Bonus!** All three options include a waiver for pre-existing medical conditions, at no additional cost to you, if you buy any one of the three options before your put down your final trip payment! (It must be before, not the same day you put down your final payment).
