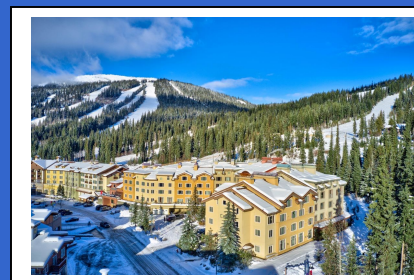

IMPORTANT AIR INFO: To avoid an unnecessarily long transfer, this is how things will work:. Participants will book OWN AIR in Kelowna, BC on Friday February 27. A hotel will be set up near the airport for Friday arrivals. The coach will pick everyone up at the hotel Saturday mid-morning and transfer to Sun Peaks. The following Friday, March 6, we will ski until 4:00 pm, then take the coach back to Kelowna, BC. A hotel set up again near the airport. Participants will be able to arrange early morning flights for your return home. The travel time will approximately 2 hr 15 min. Kelowna Air is being used because it is a larger airport and MORE flight options. Kamloops only has flights via Calgary or Vancouver, AND Air routes to Kamloops require 2 stops! Participants can get into Kelowna with 1 stop, or Toronto non-stop.

Said leaders are not professionally trained, but undertake the trip/activity leadership to the best of their knowledge and ability and spend many hours during and off-season, organizing, arranging and leading trips and events.

Release and Waiver of Liability and Indemnity Agreement to the Western PA Ski Council

I, the below named individual, being 21 years of age or older, in consideration of services which have been or will be performed by the Western PA Ski Council, in providing travel arrangements and activities and of being permitted to participate in the Council trips, activities, events and other functions which

I recognize as being hazardous, do for myself, my personal representatives, and next of kin:

- (1) hereby release, waive, discharge and covenant not to sue or hold liable the Western PA Ski Council, its officers, directors, event leaders and trustees, all for the purposes herein, referred to as Releases, from all loss or damage and any claims or demands therefore, on account of injury to the person or property, or resulting in death, whether caused by the negligence of Releases or otherwise, while for any purpose participating in any event or activity; and
- (2) hereby agree to indemnify and save and hold harmless the Release from any loss, liability, damage, or the cost they may incur due to my presence and or participating during any activity, and whether caused by the negligence of the Release or otherwise; and
- (3) Hereby assume full responsibility for any risk of bodily damage, death or property damage due to negligence of Release or otherwise while traveling, participating or for any purpose while engaged in such activities. I expressly agree that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted in the state, states, and countries in which the activity is conducted and that if any portion thereof is held invalid, it is agreed that the balance of the agreement shall continue in full legal force and effect.
- (4) Hereby acknowledge and understand all the listed details, the charged costs, fees, and any applicable refunds, if any, in the event I cancel.

I have read and voluntarily signed the Release and Waiver of Liability and Indemnity Agreement, which shall remain in full legal force and effect until such time that I notify the Western PA Ski Council in writing that this agreement is voided.
