COST \$1325 Regular, \$1470 Studio Land Package Based on Double Occupancy, includes a Room, Breakfast, Elk dinner, 4-day lift ticket, and a day trip to Grand Targhee. (PIT Air \$560) (Regular room, 2-queens & refig), (Studio, microwave, refig, fireplace, couch, large room) I have 10 rooms booked and 10 studios booked, first come, first served. Trip is reserved for 40 people at this price.

Participants will enjoy a 4 day lift ticket of skiing at Jackson Hole Ski Area. (Vert. Drop 4139'). Discounts for seniors (age 65 and older), they will be calculated on your final payment. Adjustments made for 5-day Lift, Senior Discount, or IKON Purchase. Get \$60 off room (I will calculate on final payment) when you buy your IKON through Winter Ski & Sports, www.winterskiandsport.com and click on IKON order tab. **BE CAREFUL AND PURCHASE THE RIGHT PASS.** IKON BASE PLUS PASS IS \$729 PLUS \$150 FOR JACKSON/ASPEN. Must be on this trip to qualify for room discount. The extra day you could ski SNOW KING, you would be on your own to purchase a 1-day lift ticket. Pricing this trip is a little complex, as there are many options. Your lift ticket for Jackson Hole is \$618 for a 4-day pass and \$751 for a 5-day pass. The IKON price quoted here is the price as of March 18, 2021, IKON does raised the price the later you wait. WPSC is not responsible for any price increase due IKON raising their price. Purchase early to avoid any increase.

Accommodations:

49er, Jackson Hole. Located 6300 feet above sea level in Jackson Hole, Wyoming. 15 minute shuttle ride to mountain.

Release and Waiver of Liability and Indemnity Agreement to the Western PA Ski Council

Statement of Purpose: The Western PA Ski Council provides services such as ski trips and activities as a benefit to member clubs through the participation of volunteer leaders who receive no discounts or compensation for their service. Said leaders are not professionally trained, but undertake the trip/activity leadership to the best of their knowledge and ability and spend many hours during and off-season, organizing, arranging and leading trips and events.

I, the below named individual, being 21 years of age or older, in consideration of services which have been or will be performed by the Western PA Ski Council, in providing travel arrangements and activities and of being permitted to participate in the Council trips, activities, events and other functions which I recognize as being hazardous, do for myself, my personal representatives, and next of kin:

- (1) Hereby release, waive, discharge and covenant not to sue or hold liable the Western PA Ski Council, its officers, directors, event leaders and trustees, all for the purposes herein, referred to as Releases, from all loss or damage and any claims or demands therefore, on account of injury to the person or property, or resulting in death, whether caused by the negligence of Releases or otherwise, while for any purpose participating in any event or activity; and
- (2) Hereby agree to indemnify and save and hold harmless the Release from any loss, liability, damage, or the cost they may incur due to my presence and or participating during any activity, and whether caused by the negligence of the Release or otherwise; and
- (3) Hereby assume full responsibility for any risk of bodily damage, death or property damage due to negligence of Release or otherwise while traveling, participating or for any purpose while engaged in such activities. I expressly agree that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted in the state, states, and countries in which the activity is conducted and that if any portion thereof is held invalid, it is agreed that the balance of the agreement shall continue in full legal force and effect; and
- (4) Hereby acknowledge the agreement of the Carriage of Contact of the airlines.
